

This is for your kind information, and for taking the necessary step(s) of action(s), if any, that, today, i.e., on 05/09/2021, at 12.00 noon, a joint raid has been conducted by the undersigned, the Block Development Officer, Raghunathpur - I, and the Inspector-in-Charge, Raghunathpur, along with their team members, and two stock points, having sand, stored, illegally, been raided. However, people nearby could not or did not say the names associated herewith. Hence, all the sands have been seized, which tends to be of 8000 cft (Eight Thousand cft), and handed over, through the Zimmanama, to Joy Majee, with an instruction, provided to him, to keep that sand, till further order and/or communication, from this end.


