I, Sri Raj Kumar Shaw, son of Binod Shaw aged about 31 years residing at Maya Nagar, Barakar, PS – Kulti, Paschim Bardhaman working for gain at Ujjivan Small Finance Bank Ltd., having its branch office at Ujjivan Small Finance Bank Ltd, Ground Floor, GT Road, Kulti Rani Tala 'BNR Gate, Kulti, West Bengal ,713343, do hereby intimate you as follows: -

On 14.09.2021 at around 1.40 pm while moving from Raidih centre meeting to another centre meeting at Kotaldih at that time on Bero – Ramkanali pitch road, near Ramchandrapur Sadhu Ashram ground two mobsters came on bike with having mask on their face, forcibly snatched my collection money bag of Rs.31808/- along with TAB (Samsung), other official documents & my Aadhaar card which were in my bag at the point of knife. CIT was in my pocket which is available.

Therefore, request you to lodge this complaint and book the culprits under due process of law as well as request you to provide police patrolling in this location as we are suffering from a sense of insecurity, as being, bank employees, we have to visit this area time and again during our official duty hours for repayment collection, therefore, request you to take a note of the issue and do the needful under the prevalent laws of India.
