Whereass Sumit Chatterjee, S/O Late Chittaranjan Chatterjee and Amit Chatterjee, S/O Late Chittaranjan Chatterjee, both residing at Nanduara, Raghunathpur, being based on a false notary affidavit (Annexure 1: 2 Pages), collected a legal heir certificate from the Chairperson, Board of Administrators, Raghunathpur Municipality (Annexure II: 1 Page);

Whereas, on the basis of that so-called legal heir certificate, as well as, of the false claim, made by Sumit Chatterjee, S/O Late Chittaranjan Chatterjee and Amit Chatterjee, S/O Late Chittaranjan Chatterjee, both residing at Nanduara, Raghunathpur, on the day of 13/09/2020, had their new Khatians opened;

Whereas, the undersigned, through a complaint made in the grievance portal, in this regard, got to know, in February, 2021, that, there were 8 more claimants, related to that property, concerned;

Whereas, the undersigned, being empowered with the Order, vide No. 213-15/10/2020, dated 17/01/2020, from the Office of the Principal Secretary & Land Reforms Commissioner, Land & Land Reforms and Refugee Relief and Rehabilitation Department, Government of West Bengal (Annexure III: 1 Page), immediately deleted the Khatians, numbered 2749, and 2750 (Mouza: Bakhra, JL No. 176), associated therewith, of Sumit Chatterjee, S/O Late Chittaranjan Chatterjee and Amit Chatterjee, S/O Late Chittaranjan Chatterjee, both residing at Nanduara, Raghunathpur;

Whereas, Sumit Chatterjee, S/O Late Chittaranjan Chatterjee and Amit Chatterjee, S/O Late Chittaranjan Chatterjee, both residing at Nanduara, Raghunathpur, since then on, have, through several legal notices and/or letters, made to and/or for the undersigned, as well as, to and/or for other Offices too, have been claiming, that, they are the only two successors of Late Nirmal Ch. Chatterjee, whereas, the fact is, that, Late Nirmal Ch. Chatterjee has ten successors, where Sumit Chatterjee, S/O Late Chittaranjan Chatterjee and Amit Chatterjee, S/O Late Chittaranjan Chatterjee, both residing at Nanduara, Raghunathpur, are two of them only (Annexure IV: 3 Pages; Annexure V: 4 Pages);

Whereas, the undersigned, through the communication, initiated from his side, with the Chairperson, Board of Administrators, Raghunathpur Municipality, received the proof, that, in the earlier legal heir certificate, arranged, from the end of the Chairperson, Board of Administrators, Raghunathpur Municipality, that, the legal heir certificate, issued later, containing the names of ten claimants were true (Annexure VI: 4 Pages;

Whereas, the undersigned himself looked into this matter, following the modes of hearings, as well as enquiry, and concluded, that, the legal heir certificate, concerned, containing the names of ten successors would be full and final, and accordingly restored the name of Late Nirmal Ch. Chatterjee;

Whereas, meanwhile Sumit Chatterjee, S/O Late Chittaranjan Chatterjee and Amit Chatterjee, S/O Late Chittaranjan Chatterjee, both residing at Nanduara, Raghunathpur threatened a staff of this establishment, and for that, a complaint has already beenlodged against them (Annexure VII: 4 Pages);
