Jumrali Alam of Vill- 192 Rasool Bagh (Behind GM Banglo) PS- Jharia, Dist- Dhanbad (Jharkhand), I SI Biswajit Murmu, In-charge of Santaldih I/C BCW do hereby lodged this complaint that today (24/09/2021) at 17.15 hrs, when myself along with force were engaged in course of mobile duty at Bogra Cinematola, found the above noted persons were moving at Bogra Cinematola under Santaldih PS, without wearing Mask or any face guard, as such I detained them on that spot. On being asked the above noted persons could not able to give any satisfactory answer for not wearing Mask / face guard in this pandemic situation and loitering without any purpose. As such the above noted persons violated the order during the pandemic situation duly promulgated by Govt. of WB in c/w Corona virus/Covid-19 vide order no. 647-ISS/2M-22/2020, Dated- 15.05.2021. Moreover, all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society. Accordingly, the above noted persons were arrested after maintaining all the formalities regarding arrest and brought them to PS.

Under above circumstances I therefore pray that a case U/S 188/34 IPC & read with section 51(1)(b) of Disaster Management Act, 2005 may kindly be initiated against nine (09) arrested accused persons namely (1) Tapas Bouri (28), S/o- Helu Bouri of Vill- Ichhar (2) Pramananda Rajwar (41) S/o- Lalu Rajwar of Vill- Ushir (3) Tarkeswar Rewani (25) S/o- Sarbani Rewani of Vill- Joradih, (4) Subrata Mahato (21), S/O Sanatan Mahato of Aguitard, **SL No 1 to 4 PS- Santaldih, Dist- Purulia.** (5) Bamapada Mahato (25) S/o- Madhusudan Mahato of Vill- Rukni, PS- Raghunathpur, Dist- Purulia. (6) Khepu Mandal (40), S/O Lt.
