Sub: Prayer for lodging FIR against accd. (1) Sufal Bouri (56), S/O Lt. Nakul Bouri of Nabagram, PS-Santaldih Dist-Purulia U/S 46A (c) B.E. Act 1909.

Sir,

In producing herewith arrested accused (1) Sufal Bouri (56), S/O Lt. Nakul Bouri of Nabagram, PS-Santaldih Dist- Purulia along with seizure - list and seized items as described below, I beg to state that on 16.09.2021 at about 19.15 hrs received a source information to the effect that the country spirit (Dilkhush) has been kept at Nabagram in the house of above noted accused illegally with an object to sale. I convey the matter to duty officer ASI Rabin Mukherjee of Santaldih I.C (BCW) under this PS. He has diarized the information vide Santaldih IC (BCW) GDE No- 253, dated 16.09.2021 and also informed the matter to I.C. Santaldih PS and as per order of I.C Santaldih P.S. I along with force left for BCW Bus-stand to work out the information with the govt. supplied kits box containing white cloth, sealing wax, seal, papers, carbons, match box, candles etc. I had been to the house of Sufal Bouri at Nabagram, P.S. Santaldih at about 19:35 hours. Seeing police van some unknown persons in front of the house of Sufal Bauri fled away. However, I could detain one among them and asked about his identity. He revealed his name and identify as above and as well as informed also that he gather the country spirit (Dilkhush) for selling and he was the owner of the said house. However, I along with said accused started a search inside the house of Sufal Bouri and found the following item in the said house.

> 1) 20 (Twenty) bottles 80UP country spirit (Dilkhush) each bottles containing 600 ML market value of each being in total approx Rs. 1,000/ - (One Thousand only)

> 01 (one) bottle of 600 ML taken (Dilkhush) out of the above as sample packet, labeled and sealed with sealing wax.

Sale Proceed cash of Rs.- 165/- (One hundred sixty five only)

I interrogated him about the purpose of the stocking and possessing country spirit. He replied it was the business of him. On repeated question he told that the persons who fled away were his customers (names of those not known to him). However he could not show any documents/papers in support of the possession as well as sale of the said articles.

As such, I seized the above items as ALAMAT under proper Seizure List between 19:55 hrs and 20.15 hrs & took up one bottle of each brand as samples, labeled and sealed accordingly.

Since the allegation against him of possessing, as well as selling the country spirit illegally without any valid papers in his house has prima-facie been made out and for the interest of proper investigation. I arrested the above accused at 20.25 hrs accordingly.

Therefore, I pray before you to start a case under proper section of law against the said

accused Sufal Bouri (56), S/O Lt. Nakul Bouri of Nabagram, PS-Santaldih Dist-Purulia.
