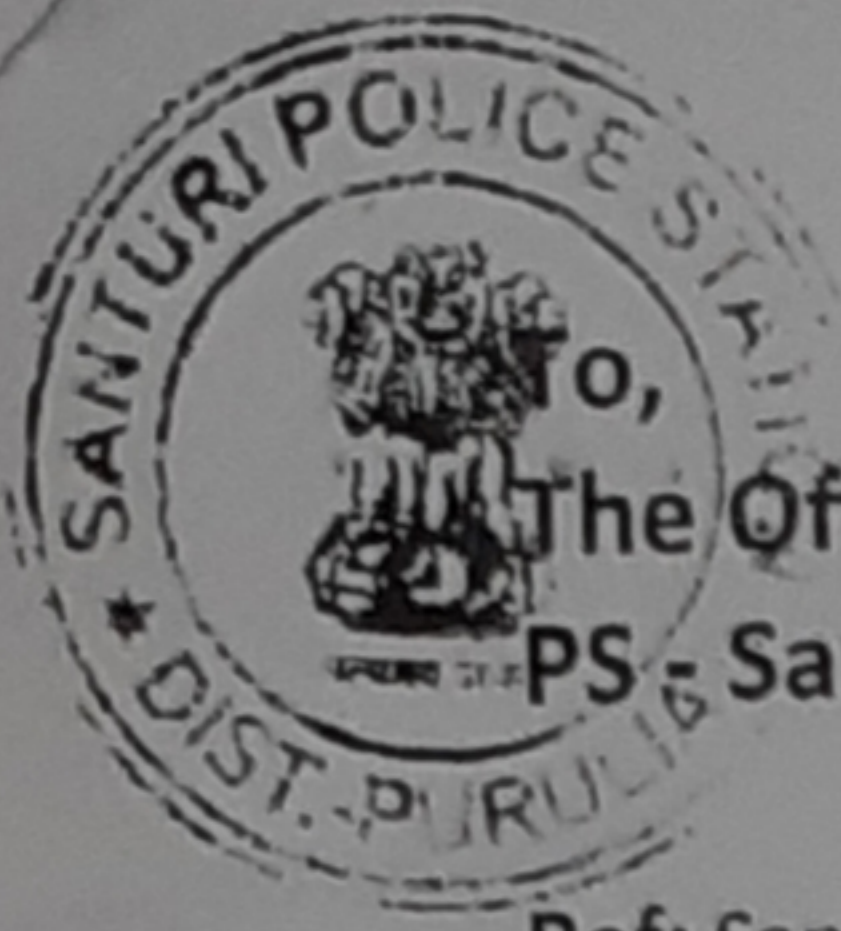

Sub: Complaint against Nimai Mishra (49 Yrs), S/O- Lt. Giridhari Mishra of Vill- Sunuri, P.S - Santuri, Dist - Purulia to start a cog case U/S- 46A(C) B.E. Act 1909.

Respected Sir,

In producing here with the arrested accused person Nimai Mishra (49 Yrs), S/O- Lt. Giridhari Mishra of Vill- Sunuri, P.S - Santuri, Dist - Purulia along with 15 liters 600 ml Country Spirit (26 bottle X 600ml) value of Rs- 50 X 26= 1300/- seized under proper seizure list, I beg to submit that today (on 16.09.2021) I along with force while performing evening mobile duty at about 21:55 hrs received a credible source information that one person namely Nimai Mishra (49 Yrs), S/O- Lt. Giridhari Mishra of Vill- Sunuri, P.S - Santuri, Dist - Purulia is stocking and selling Country Spirit without any valid license from his dwelling house at Vill-Sunuri, P.S - Santuri, Dist - Purulia. Accordingly, I along with force had been to the spot at about 22:15 hrs for Sunuri village to work out the source information and held raid into the premises of above mentioned accused person. I like to note here that seeing the Police personnel, customers were fled away. During search with the help of accompany force, we found that the said person is stocking Country Spirit bottles for sell. On demand, he failed to produce any valid documents/ License in respect of selling and keeping of Country Spirit bottles. Accordingly, I arrested him after preparing proper arrest memo as he committed offence U/S- 46A(C) B.E. Act 1909 and supply one copy to him. Then, I seized and labeled 26 (twenty-six) bottle 'DIL KHUSH' country spirit containing 600ml each bottle and amounting Rs-50/- (Fifty) each bottle, Total amounting Rs- 1300/- under proper seizure list duly signed by the witnesses out of which one bottle is sealed and labeled as sample.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S- 46A (C) B.E. Act 1909 against the arrested accused person namely Nimai Mishra (49 Yrs), S/O- Lt. Giridhari Mishra of Vill- Sunuri, P.S - Santuri, Dist - Purulia and arrange for its investigation.
