In producing herewith one arrested accused person namely Mukta Mahato (42 yrs) S/O- Paresh Mahato of Vill- Belguma, P.S- Tamna, Dist.- Purulia with seizure list and seized articles, I beg to submit that today i.e on 11.09.2021 at about18:05 hrs during special mobile duty, received a secret source information and as per order of O/C Tamna PS, I PSI Surajit Kr.
