I, PSI Surajit Kumar Das S/O- Samir Kumar Das along with force returned to PS and brought 01 (One) seized blue colour Sonalika Tractor, DI-35 bearing Registration No- WB55B/1800 (Engine No- 3100FLU93B829730F18 & Chassis No - AZJSS832106SM) along with sand (Approx 100 cft.) loaded trolley and lodged this complaint to the effect that on 12.09.2021, myself along with force i) C/1454- Ashok Kumar Mahato and ii) C/1021- Laxmikanta Bauri of Tamna PS were performing PS area Day mobile duty. During my mobile duty on 12.09.2021 at about 15:55 hrs received credible source information that One blue colour Sonalika Tractor, DI-35 bearing Registration No- WB55B/1800 is lifting sand illegally at Dumurshol Ghat under Tamna PS jurisdiction area. Accordingly myself along with force left to work out the said source information. Then, we intercepted the aforesaid tractor at Dumurshol Bridge under Tamna PS at about 16:45 hrs and found that the above noted tractor was tagged with a trolley loaded with sand (approx 100 cft.). But seeing the Police party, the driver of the said tractor fled away leaving his tractor with sand loaded trolley at Dumurshol Bridge under Tamna PS. We tried to apprehend him but failed. So there is every ground to reason to belief that the owner and driver of the above noted tractor dealing in sand business in clandestine manner. We waited for reasonable time but none came forward and produce any proper challan or any valid documents related to the said loaded sand of above detained tractor. So, I seized the above noted blue colour Sonalika Tractor, DI-35 bearing Registration No- WB55B/1800 (Engine No- 3100FLU93B829730F18 & Chassis No – AZJSS832106SM) along with sand (Approx 100 cft.) loaded trolley.

On return to Tamna PS, kept the aforesaid sand loaded seized tractor at PS compound and I do here by submitting written complaint before you to start a cog case against the owner and driver of the said blue colour Sonalika Tractor, DI-35 bearing Registration No- WB55B/1800 (Engine No-3100FLU93B829730F18 & Chassis No – AZJSS832106SM) along with sand (Approx 100 cft.) loaded trolley under proper section of law.
