Respected Sir,

In producing herewith one arrested accused person namely Hrishikesh Mahato (40 yrs) S/O- Lt. Krishnapada Mahato of Vill- Tamna, P.S- Tamna, Dist - Purulia with seizure list and seized articles, I beg to submit that today i.e on 23/09/2021 at about 23:45 hrs during special mobile duty, received a secret source information and as per order of O/C Tamna PS, I ASI Gnan Sankar Pati of Tamna PS along with force had been to Durku more under Tamna PS at 23:55 hrs and as per indication conducted raid in the Pan Stall of Hrishikesh Mahato (40 yrs) S/O- Lt. Krishnapada Mahato of Vill- Tamna, P.S- Tamna, Dist- Purulia and detained one person. On asking his identity he disclosed his identity as noted above. On interrogation he confessed his guilt for selling and possession of country spirit styled as DII KHUSHI. On demand he failed to produce any valid documents in respect of stock and selling of said country spirit at his Pan Stall. As such I seized (i) 05 (five) sealed Bottles of country spirit styled as DII KHUSHI each bottles contains 600 ml. (ii) 25 (twenty five) sealed Bottles of country spirit styled as DII KHUSHI each bottles contains 300 ml. One bottles taken from each country spirit styled as DII KHUSHI of 600 ml, 300 ml as sample under proper Seizure List in presence of witnesses and signed by witnesses and accused person. Arrested the above noted accused person after observing all legal formalities regarding arrest. Informed him the ground of his arrest. The seized articles were properly sealed and label in presence of witnesses duly signed by them and accused person.

The above noted accused person namely Hrishikesh Mahato (40 yrs) S/O- Lt. Krishnapada Mahato of Vill- Tamna, P.S- Tamna, Dist.- Purulia committed offence u/s- 46 A(c) B.E. Act- 1909 for unauthorized possession and sales of country sprit (DII KHUSHI) from his Pan Stall

Under the fact and circumstances kindly take necessary lawful action against Hrishikesh Mahato (40 yrs) S/O- Lt. Krishnapada Mahato of Vill- Tamna, P.S- Tamna, Dist.- Purulia.
