Respected Sir,

In producing herewith one arrested accused person namely Bishnu Gope (26 yrs) S/O- Bipin Gope of Vill- Chakaltore, P.S- Tamna. Dist.- Purulia with seizure list and seized articles, I beg to submit that today i.e on 24.09.2021 at about 00:05 hrs during Special mobile duty, received a secret source information and as per order of O/C Tamna P.S, I ASI Jagannath Rakshit of Tamna PS along with force had been to Chakaltore village under Tamna PS at 00:15 hrs and as per indication conducted raid in the house of Bishnu Gope (26 yrs) S/O- Bipin Gope of Vill- Chakaltore, P.S- Tamna, Dist.- Purulia and detained one person. On asking his identity he disclosed his identity as noted above. On interrogation he confessed his guilt for selling and possession ID Liquor. On demand he failed to produce any valid documents in respect of stock and selling of said ID Liquor at his house. As such I seized two Jars of ID Liquor each containing approx 09 (Nine) Liters of ID Liquor, some portion (Approx One Liter) of ID Liquor as sample under proper Seizure List in presence of witnesses duly signed by witnesses and accused person. Arrested the above noted accused person after observing all legal formalities regarding arrest. Informed him the ground of his arrest. The seized articles were properly sealed and label in presence of witnesses duly signed by them and accused person.

The above noted accused person namely Bishnu Gope (26 yrs) S/O- Bipin Gope of Vill- Chakaltore, P.S- Tamna, Dist.- Purulia committed offence u/s- 46 A(c) B.E. Act- 1909 for unauthorized possession and sales of ID Liquor from his house.

Under the fact and circumstances kindly take necessary lawful action against Bishnu Gope (26 yrs) S/O- Bipin Gope of Vill- Chakaltore, P.S- Tamna, Dist.- Purulia.
