In producing herewith one arrested accused person namely Bishnu Gope (26 yrs) S/O- Bipin Gope of Vill- Chakaltore, P.S- Tamna. As such I seized two Jars of ID Liquor each containing approx 09 (Nine) Liters of ID Liquor, some portion (Approx One Liter) of ID Liquor as sample under proper Seizure List in presence of witnesses duly signed by witnesses and accused person. Arrested the above noted accused person after observing all legal formalities regarding arrest. Informed him the ground of his arrest. The seized articles were properly sealed and label in presence of witnesses duly signed by them and accused person.

The above noted accused person namely Bishnu Gope (26 yrs) S/O-Bipin Gope of Vill- Chakaltore, P.S- Tamna, Dist.- Purulia committed offence u/s-46 A(c) B.E. Act- 1909 for unauthorized possession and sales of ID Liquor from his house.

Under the fact and circumstances kindly take necessary lawful action against Bishnu Gope (26 yrs) S/O- Bipin Gope of Vill- Chakaltore, P.S- Tamna, Dist.- Purulia.
