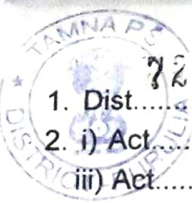

Respected Sir,

I, SI Bikash Ch. Patra of Tamna PS along with force returned to PS and brought 08 (Eight) numbers of seized e- Rickshaw, bearing Registration Nos- (i) WB55B/0454 with sand loaded 08 (Eight) numbers of plastic Sack, (ii) WB55B/1380 with sand loaded 09 (Nine) numbers of plastic Sack, (iii) WB55B/0416 with sand loaded 07 (Seven) numbers of plastic Sack, (iv) WB55B/0300 with sand loaded 10 (Ten) numbers of plastic Sack, (v) WB55B/0157 with sand loaded 09 (Nine) numbers of plastic Sack, (vi) WB55A/9758 with sand loaded 08 (Eight) numbers of plastic Sack, (vii) WB55B/1597 with sand loaded 09 (Nine) numbers of plastic Sack and (viii) one blue colour e- Rickshaw without number plate with sand loaded 10 (Ten) numbers of plastic Sack and lodged this complaint to the effect that on 16.09.2021, myself along with force i) C/152- Paresnath Bauri and ii) NVF/1028- Rajesh Kr. Mahato of Tamna PS were performing PS mobile duty. During my mobile duty on 16.09.2021 at about 10:35 hrs received credible source information that 08 (Eight) e- Rickshaws are lifting sand illegally from Kansai Riverbed at Dumursole Ghat under Tamna PS jurisdiction. Accordingly myself along with force left to work out the said source information. Then, we intercepted the aforesaid 08 (Eight) e- Rickshaws at Dumursole Village on Old Manbazar Road under Tamna PS at about 11:15 hrs and found that the above noted e- Rickshaws are loaded with sand. But seeing the Police party, the drivers of the above noted e- Rickshaws fled away leaving their e- Rikshaws with loaded sand at Dumursole Village on Old Manbazar Road under Tamna PS. We tried to apprehend them but failed. So there is every ground to reason to belief that the owners and drivers of the above noted e- Rikshaw dealing in sand`business in clandestine manner. We waited for reasonable time but none came forward and produce any proper challan or any valid documents related to the said loaded sand of above detained e- Rikshaws. So, I seized the above noted 08 (Eight) e- Rickshaws, bearing Registration Nos- (i) WB55B/0454 with sand loaded 08 (Eight) numbers of plastic Sack, (ii) WB55B/1380 with sand loaded 09 (Nine) numbers of plastic Sack, (iii) WB55B/0416 with sand loaded 07 (Seven) numbers of plastic Sack, (iv) WB55B/0300 with sand loaded 10 (Ten) numbers of plastic Sack, (v) WB55B/0157 with sand loaded 09 (Nine) numbers of plastic Sack, (vi) WB55A/9758 with sand loaded 08 (Eight) numbers of plastic Sack, (vii) WB55B/1597 with sand loaded 09 (Nine) numbers of plastic Sack and (viii) one blue colour e- Rickshaw without number plate with sand loaded 10 (Ten) numbers of plastic Sack.

On return to Tamna PS, kept the aforesaid sand loaded seized 08 (Eight) e- Rickshaws at PS compound and I do here by submitting written complaint before you to start a cog case against the owners and drivers of the said e- Rickshaw's under proper section of law.
