In producing herewith one arrested accused person namely Sujit Majhi (41 yrs) S/O- Lt. Ankur Majhi of Vill- Matkumdih, P.S- Tamna, Dist- Purulia with seized ID Liquor and seized articles, I beg to submit that today i.e on 16.09.2021 at about 18:05 hrs during special mobile duty, received a secret source information and as per order of O/C Tamna P.S, I SI Hemanta Kr. Sahababu of Tamna PS along with force had been to Matkumdih village under Tamna PS at 18:35 hrs and as per indication conducted raid in the house of Sujit Majhi (41 yrs) S/O- Lt. Ankur Majhi of Vill- Matkumdih, P.S- Tamna, Dist.- Purulia and detained one person. On asking his identity he disclosed his identity as noted above. On interrogation he confessed his guilt for selling and possession ID Liquor. On demand he failed to produce any valid documents in respect of stock and selling of said ID Liquor at his house. As such I seized two Jars of ID Liquor each containing approx 08 (Eight) liters of ID Liquor, some portion (Approx One Liter) of ID Liquor as sample under proper Seizure List in presence of witnesses duly signed by witness and accused person. Arrested the above noted accused person after observing all legal formalities regarding arrest. Informed him the ground of his arrest. Seized articles were properly sealed and label in presence of witnesses duly signed by them and accused person.

The above noted accused person namely Sujit Majhi (41 yrs) S/O- Lt. Ankur Majhi of Vill- Matkumdih, P.S- Tamna, Dist- Purulia committed offence u/s- 46 A(1) B.E. Act- 1909 for unauthorized possession and sales of ID Liquor from last one.
