Sub: Request for lodging F.I.R. against arrested accused person 1) Bittu Gorai (21 Yrs) S/O Shamapada Gorai of Vill-Palashkola, PS-Adra, Dist-Purulia & 06 others.

Sir,

In producing herewith 07 (Seven) arrested accused persons namely 1) Bittu Gorai (21 Yrs) S/O Shamapada Gorai (2) Bablu Bauri (21 Yrs) S/O Ananda Bauri both of Vill-Palashkola, PS-Adra, Dist-Purulia (3) Ambarish Majhi (28 Yrs) S/O Sarbeswar Majhi of Vill-Dhabari, PS-Adra, Dist-Purulia (4) Chiranjit Karmakar (35 Yrs) S/O Biswanath Karmakar of Vill-Kashipur, PS-Kashipur, Dist-Purulia (5) Sourav Mandal (19 Yrs) S/O Arup Mandal (6) Lalchand Majhi (21 Yrs) S/O Lt. Arun Majhi (7) Ashish Mandal (28 Yrs) S/O Jadab Mandal all of Vill-Paachapalaari, PS-Raghunathpur, Dist-Purulia with all connected papers.

I beg to state that, today (07.10.2021), I was directed to find out whether the guidelines of Govt regarding not wearing face musk in public and restriction of movement accept emergency from 23:00 hrs to next day 05:00 hrs in this pandemic situation has been implemented properly at Adra Bazar area or not. Accordingly, I had been to Chatna More Adra, along with force vide Adra PS CC NO-3687/21 dtd.07.10.2021 at about 22.55 hrs and found that a gathering appeared Chatna More none of them was wearing face musk. On seeing Police party they have tried to escape from the grip of police party but seven failed to escape due to efficiency effort of police party. On being asked they disclosed their identity as noted above.

They violated the order duly promulgated by government through public servants and through media etc for prevention of attack from CORONA Virus/COVID-19. Though in view of Pandemic of COVID-19 restriction of movement except emergency from 23:00 hrs to next day 05:00 hrs in the current pandemic disaster situation by restriction order No. 753/X – ISS/2M -22/2020 dated. 30/09/2021 of Government of West Bengal. They are creating annoyance to the society & violated this govt. order.

I arrested them for disobedience to order duly promulgated by public servant after maintaining all rules of arrest, Issued memo of arrest & Inspection Memo. I informed them & their relative regarding the ground of arrest provide penalties for disobeying any regulation or order made under the Act. These are according to Section 188 of the Indian Penal Code (Disobedience to order duly promulgated by public servant). A prima facie there were sufficient evidences to secure their detention. All the process was done at 23.05 hrs to 23.15 hrs. There was every chance of speared of Infection of disease COVID-19(CORONA VIRUS) which is endanger of human life.

Therefore, I pray a specific case U/S 188/34 IPC and Section 51(1)(b) National Disaster Management Act- 2005 may kindly be lodge against 07 accused persons as noted above. As they disobeyed Govt. order and committed negligent Act likely to spread infection of diseases which is dangerous to lie and arrange for investigation.
