With due reverence I Rajbir Kaur, wife of Sardar Rajendar Singh Chhabra, daughter of Sardar Satpal Singh presently residing at C/O Sardar Satpal Singh, Adra Post Office: Adra, Police Station: Adra, District: Purulia like to draw your kind attention to the fact that I was married to Sardar Rajendar Singh Chhabra, son of late Sardar Manmohan Singh Chhabra, of S. P Mukherjee Bye Lane, Post Office: Asansol-713303, Police Station: Asansol (South), District: Paschim Bardhaman, West Bengal and our marriage was solemnised on 17th October 2008 at Gurunanak Nagar, Rambandhu Talab, Post Office: Asansol-713303, Police Station: Asansol (South), District: Paschim Bardhaman, West Bengal according to Sikh rituals and customs. It was a love cum arranged marriage.

1. That in consideration of the said marriage my parents gave a cash of Rs. 5,00,000/= (five Lack) alongwith Ladies Golden Ornaments worth of 10 Bhari, Silver Ornaments worth Rs. 50,000/-, Wooden Furniture worth Rs. 2 Lac, Cooking Utensils worth of Kansa & Steel amounting to Rs. 50,000/-, one Steel Alamira, bedding, clothing, a gents golden chain and a gents golden ring totaling 2 Bhari, all the electronic equipments like TV, Fridge, AC, Kitchen Utensils. At the time of marriage the renovation was going on in my husbands house, they demanded Cash for the said renovation and my father got an Fixed deposit of Rupees 6,00,000/- and many other articles were presented unto my husband as per the demand of the mother and other family members of my husband and on the very next date of reception of marriage, as per the demand I have handed over all the golden & silver ornaments to my mother-in-law and she took all those ornaments for the purpose of keeping the same in safe custody and my sister-in-law namely Nilu Saluja and her husband Sardar Taranjeet Singh assured me that on my demand the same will be returned unto me.

The problem started on the very day of the marriage, as my elder sister-in-law Nilu Saluja started complaining about the food, she started criticizing my father and my family about the quality of the products, the weight of the ornament, gold that had been given by my father in our marriage. The situation got so worsed that I was not even allowed to come to my paternal house for the Pagghera (on 19/10/2008,) which is an important part of the marriage according to the sikh rituals and my husband kept himself mum.

That, my elder sister-in-law Nilu Saluja waged a war against me, she threatened me that she would make my life hell, and she would ensure that my husband left me. and She started creating false and manipulated stories and presented them when my husband was at home. Although it was a love marriage, my husband never understood my pain and took my side, but on several occasions he had beaten me by taking his sister's and mother's side.

However, within a short time I realized that and my mother-in-law (Jaspal Kaur Chhabra), instead of recognizing me as their daughter-in-law, started treating me as their maid servant. I swallowed everything with the expectation that over the passage of time everything would be set at right but in vain. I was further surprised when I narrated the attitude of my mother-in-law towards me to my husband, he too took their side and started blaming me with the accusation that I picked up quarrels with my mother-in-law. I swallowed even such attitude of my husband and waited for good times to come but day in and day out the intensity of torture upon me increased to such an extent that I was bound to raise my voice over which the scene physically assaulted me. I was compelled to divulge everything to my parents and my parents on numerous occasions tried to convince my husband and in-laws to keep me with care but they also behaved rudely with my parents.

That within short span of time I realized that my mother-in-law, my sister-in-law & his entire family instead of recognizing me as member of their started treating me as their maid servant, I was forced on each day to wake up at 4.30 A.M. in the morning and went to sleep at 11.00 P.M. at night and all day the above persons found fault in all my works and abused me without any filthy language without any fault on my part. I was also not provided with proper food and forced to live like an outsider in my own matrimonial house.

That, after marriage, when trying to conceive I developed a few gynecological problems, I had to undergo a couple of operations. Whenever my abdominal pain would start, I used to tell my mother-in-law and my husband, they never cared. Neither they took me to the doctor on time, nor allowed me to go out of the house to get treatment. The expenses of the operations I had to undergo were borne by my father. My husband never took any responsibility for me. I was not given even a little amount as pocket money. I had to depend on my father for everything I needed even for a 'Sanitary napkin'.

That, the torture was getting worse day by day and my elder sister-in-law, my mother-in-law, my husband became so cruel, every now and then they used to ask me leave the house.

That, after my marriage I completed my M.com Degree and the entire expense was borne by my father and my husband flatly refused to bear the expense of my education.

That I got pregnant with lots of complications after 7 years of my marriage, I was so happy and excited, I thought now the problem between me and my husband would end, but I was wrong, as I got pregnant with so much difficulties and was asked for bed rest for entire pregnancy, but again my sister-in-law and my mother-in-law started commenting on my bedrest, they made me work assaulted me so many times knowing that my pregnancy was high risk pregnancy and my husband was a passive onlooker into the matter, I understood that family did not have any attachment for my baby also.

That on 1st November 2015, my daughter Aarjaa Kaur was born, but they were not happy as it was a girl child. As usual my husband didn't take any responsibility for the baby. The entire nursing home bill and other expenses was given by my father and my husband had no interest in her baby. Also every time I had to ask my father to meet our expenses.

I swallowed everything with the expectation that over the passage of time everything would be set at right and good sense may prevail upon them but in vain. I was further surprised when I narrated the attitude of my mother-in-law and my sister-in-law towards me to my husband, he too took their side and started blaming me with the accusation that I picked up quarrels with my mother-in-law and my sister-in-law and other family members. I swallowed even such attitude of my husband and waited for good times to come but day in and day out the intensity of torture upon me increased to such an extent that I was bound to raise my voice over which the scene physically assaulted me. My in-laws always irritate me for further dowry demands of Rs 10,00,000/- and when I refused to bring any further money, all the above mentioned abused me and my family members and suggested my husband to make a second marriage as I denied bringing any money from my parents. I was compelled to divulge everything to my parents and my parents on numerous occasions tried to convince my husband and in-laws to keep me with care but they also behaved very badly my parents.

That my sister-in-law Nilu saluja used to stay in my in-laws house very frequently and she designed all evil plans for physical and mental tortured against me and started abusing me and my parents. On that very day I asked my husband for a few rupees as I needed to buy some medicine for my daughter, he refused as usual but on my repeated request for purchasing the medicines, he asked me to leave the house immediately. They called my father and packed my stuff, clothes and everything. They asked my father to take me with him. They were never bothered by the child who is just 1.5 month old. my father took me to our house in adra, 16<sup>th</sup> May 2017.

Subsequently, in the month of February 2019 my husband came again and took me to my matrimonial house but the person continued tortured upon me but I swallowed.

My husband had demanded scooty from my father which was fulfilled by my father on my daughter's first birthday. When we separated he refused to give the scooty.

That subsequently they used to kept me in a locked room and my husband found to be addicted to wine and very recently I have come to know that my husband is having extra marital affairs with other woman and used to assault me 'off and on' and the other in-laws also instigated my husband for such inhuman misbehavior to me. The above persons disclosed that had Rajender Singh married elsewhere they would have received more



dowry money as per their demand. After that my parents several times came to my matrimonial house and tried to settle the dispute but my husband, mother-in-law, brother-in-law, sister-in-law behaved with my parents and also abused me in slang language.

I was habitually tortured physically and mentally like beast by my husband at night hours and all his family members were passive on lookers and they remained quiet silent over such inhuman tortures rather instigated my husband in his such torture and as a result I have suffered severe physical, mental & emotional stress and resulting mental depression during my stay with my in-laws since my marriage.

That on 05<sup>th</sup> July 2021 midnight, the physical & mental cruelty upon me by my husband and all of my in-laws crossed all the limits and my husband came in drunk condition and started to abuse me in filthy language and on protest my mother-in-law, brother-in-law, sister-in-law and her husband all came at my room and started assaulted me with fists and blows. My sister-in-law Nilu Saluja pulled my hair and dashed my head on the wall, my mother in law Jaspal Kaur slapped me and they drove me from my in-laws house.

That on 7<sup>th</sup> July 2021, I together with my parents went to my matrimonial house to bring my Stridhan Articles but we were not even allowed to enter into my matrimonial house. Thus my husband and in-laws misappropriated my entire stridhan articles.

After that I was staying in shristinagar at my father's flat. He came in drunk condition at night hours and threaten me and forced me to sign the divorce papers. Therefore I request to your good office to kindly lodge the complaint and take necessary steps against my husband and in-laws named above for subjecting me to cruelty of highest form and for misappropriation of my Stridhan property, at the earliest.
