Sub: Request for lodging F.I.R. against arrested accused person 1) Shiba Mukhi (30 Yrs) S/O Basudeb Mukhi of Sevanagar Adra, PS-Adra, Dist- Purulia & 16 others active members of Sevanagar Durga Puja Committee and 100 Unknown others.

Sir,

I beg to state that, today (16.10.2021), I was engaged in evening mobile duty at Adra PS area vide CC No-3557/21 dtd.16.10.2021. At about 19.45 hrs when I was near Indian Bank Adra on Adra-Raghunathpur Road then I found a immersion procession of Durga Idol was coming from Adra side. Near about 250-300 people participate in this procession and all of them not wearing face mask and not maintaining social distance. After enquiry it comes to know that the procession organized by "Sevanagar Durga Puja Committee" under the leadership of active committee members namely (1) Shiba Mukhi (30 Yrs) S/O Basudeb Mukhi (2) Rajiv Mukhi S/O Anand Mukhi (3) Kunal Mukhi S/O Anand Mukhi (4) Chintu Mukhi S/O Sahid Mukhi (5) Vishal Mukhi S/O Bablu Mukhi (6) Amit Mukhi S/O Kishore Mukhi (7) Chandan Mukhi S/O Ram Prasad Mukhi (8) Biky Mukhi S/O Not Known (9) Mantu Mukhi S/O Not Known (10) Madhu Mukhi S/O Not Known (11) Anand Mukhi S/O Not Known (12) Dipak Mukhi S/O Not Known (13) Ganesh Mukhi S/O Not Known (14) Sanjay Mukhi S/O Not Known (15) Krishna Mukhi S/O Not Known (16) Bajrang Mukhi S/O Not Known (17) Sagar Mukhi S/O Not Known all are Sevanagar Adra, PS-Adra, Dist- Purulia. I tried to stop them but as there is huge gathering so the procession went towards "Sargadwar Pond" without paying no heed to me and I unable to arrest/detain anyone.

They violated the order duly promulgated by government through public servants and through media etc for prevention of attack from CORONA Virus COVID-19. Though in view of Pandemic of COVID-19 wearing face mask and maintaining social distance and not to make huge gathering in the current pandemic disaster situation vide advisory issued vide no- 715-Home (Cons)RIM(Cons)-92/2021dated- 17.04.21 followed by restriction order No. 753/X - ISS/2M -22/2020 dated. 30/09/2021 of Government of West Bengal. They are creating annoyance to the society & violated this govt. order.

These are according to Section 188 of the Indian Penal Code (Disobedience to order duly promulgated by public servant). A prima facie there were sufficient evidences to secure their detention. There was every chance of spread of Infection of disease COVID-19(CORONA VIRUS) which is endanger of human life due to their Act.

Therefore, I pray a specific case U/S 188/34 IPC and Section 51(1)(b) National Disaster Management Act- 2005 may kindly be lodge against active committee members of "Sevanagar Durga Puja Committee namely (1) Shiba Mukhi (30 Yrs) S/O Basudeb Mukhi (2) Rajiv Mukhi S/O Anand Mukhi (3) Kunal Mukhi S/O Anand Mukhi (4) Chintu Mukhi S/O Sahid Mukhi (5) Vishal Mukhi S/O Bablu Mukhi (6) Amit Mukhi S/O Kishore Mukhi (7) Chandan Mukhi S/O Ram Prasad Mukhi (8) Biky Mukhi S/O Not Known (9) Mantu Mukhi S/O Not Known (10) Madhu Mukhi S/O Not Known (11) Anand Mukhi S/O Not Known (12) Dipak Mukhi S/O Not Known (13) Ganesh Mukhi S/O Not Known (14) Sanjay Mukhi S/O Not Known (15) Krishna Mukhi S/O Not Known (16) Bajrang Mukhi S/O Not Known (17) Sagar Mukhi S/O Not Known all are Sevanagar Adra, PS-Adra, Dist- Purulia and 100 others.
