Sub: Request for lodging F.I.R. against arrested accused person 1) Jayanta Bauri (20 Yrs) S/O Charan Bauri of Vill-Kharai, PS-Adra, Dist- Purulia & 04 Others.

Sir,

In producing herewith 05 (Five) arrested accused persons namely (1) Jayanta Bauri (20 Yrs) S/O Charan Bauri (2) Tapas Kumar Bauri (22 Yrs) S/O Suresh Ch. Bauri both of Vill-Kharai, PS-Adra, Dist- Purulia (3) Sonu Kumar (23 Yrs) S/O Ram Ch. Prasad Gupta of Ward No-4, Parsofiya Ramgarh Jharkhand A/P- Beniasol near Ridhdhi Sidhdhi Mall Adra, PS-Adra, Dist- Purulia (4) Abhishek Kumar Sarma (24 Yrs) S/O Rajkumar Sarma of New Bishnupur, near Durga mandir, PS-Dhanbad, Dist-Dhanbad (JKD) A/P- Beniasol near Ridhdhi Sidhdhi Mall Adra, PS-Adra, Dist- Purulia (5) Mitun Bauri (27 Yrs) S/O Abhoy Bauri of Vill- Chinpina, PS-Raghuathpur, Dist-Purulia with all connected papers.

I beg to state that, today (29.10.2021), I was directed to find out whether the guidelines of Govt regarding not wearing face mask in public and restriction of movement except emergency from 23:00 hrs to next day 05:00 hrs in this pandemic situation has been implemented properly at Adra town area or not. Accordingly, I had been to Mama More, South beat Adra along with force vide Adra PS CC NO-3875/21 dtd.29.10.2021 at about 23.15 hrs and found that a gathering appeared at Mama More, South beat Adra none of them was wearing face mask. On seeing Police party they have tried to escape from the grip of police party but five failed to escape due to efficiency effort of police party. On being asked they disclosed their identity as noted above.

They violated the order duly promulgated by government through public servants and through media etc for prevention of attack from CORONA Virus/COVID-19. Though in view of Pandemic of COVID-19 restriction of movement except emergency from 23:00 hrs to next day 05:00 hrs in the current pandemic disaster situation by restriction order No. 753/X – ISS / 2M – 22- 2020 Dated 30/09/2021 of Government of West Bengal. They are creating annoyance to the society & violated this govt. order.

I arrested them for disobedience to order duly promulgated by public servant after maintaining all rules of arrest. Issued memo of arrest & Inspection Memo. I informed them & their relative regarding the ground of arrest provide penalties for disobeying any regulation or order made under the Act. These are according to Section 188 of the Indian Penal Code (Disobedience to order duly promulgated by public servant). A prima facie there were sufficient evidences to secure their detention. All the process was done at 23.15 hrs to 23.25 hrs. There was every chance of spread of Infection of disease COVID-19(CORONA VIRUS) which is endanger of human life.

Therefore, I pray a specific case U/S 188/34 IPC and Section 51(1)(b) National Disaster Management Act- 2005 may kindly be lodge against 05 accused persons as noted above. As they disobeyed Govt. order and committed negligent Act likely to spread infection of diseases which is dangerous to lie and arrange for investigation.
