The above name complainant begs to state as follows:

- 1) That the complainant is the legally married wife of the accused persons and their marriage was solemnized on 13/05/2020 as per Hindu rites and customs as prevalent in their community and also by observing the formalities like putting on vermilion, exchange of garlands, Home etc. and the said marriage is still subsisting.
- 2) That at the time of marriage as per their demand father of the complainant paid a cash of Rs. 85,000/-, one Motor Bike, Golden ornaments weighing 3 bhories along with other valuable articles. But the accused persons were not fully satisfied. As because the accused persons demanded a cash of Rs. 1,50,000/-. But as father of the complainant could not able to pay the said in its entirety but only paid Rs. 85,000/-.



- 3) That after marriage as per customs the complainant was brought at his matrimonial house and started to reside therein with the said Rathu Mahato as husband and wife along with other inmates of the family under the same mess and house.
- That for about one month and so all the above the accused 4) persons behaved well with the complainant, but gradually behavior of their part somehow changed. However, the complainant never taken it to be abnormal on the other hand all the above noted persons in connivance with each other started to quarrel with the complainant and ill behaved with her without any reason, the accused persons also with some false pretax did not provide the complainant proper food and clothing even daily necessities and also driven the complainant out from their house off and on. But finding no other alternative and to keep the relation in good condition with her husband and others in laws the complainant tried her level best to console herself that everything will be normal during passage of time. And the above noted accused persons must have understood their fault and well behaved the complainant in proper manner.



- 5) That however, the above noted accused persons never mended their mind, but they increase their torture both mental and physical upon the complainant even the accused persons did not heisted to assault the complainant in various ways.
- 6) That thereafter, the accused persons all asked the complainant to bring Rs. 50,000/- more as further dowry and on non-payment the degree of torture gradually higher and the accused persons also with their common intention assaulted the complainant mercilessly.

It is very regret and shameful for the complainant to point out that the father-in-law of the complainant namely Gurupada Mahato asked the complainant for illicit relationship with him and on her refusal he also assaulted me.

In such circumstances father of the complainant bring her back at her paternal house and started to reside therein, thereafter again in the month of Ashar-1428 B.S. father of the complainant took her at her matrimonial house and the complainant again started to reside at her



matrimonial house with her husband and other in-laws of the family.

But that time the complainant became pregnant. And when those persons herd about her pregnancy then on 13/08/2021 at 6:00 pm called the above noted four persons with conspiracy assaulted the complainant and driven her out from their house, the accused persons also gave out that unless the complainant bring Rs. 50,000/- from her father they will not allow her to enter in to the house of the accused persons. Rather they will arrange second marriage of the husband of the complainant.

- 7) Ultimately finding no other alternative the complainant again returned back at her paternal house and is residing therein, but husband of the complainant and any of the inlaws, not the accused persons are arrange to bring her back to their house.
- 8) That the accused persons committed various offences punishable under the Indian penal code for which they are deserved to be punished under the law.



9) That the matter was reported to the Officer-in-charge Baghmundi P.S. against the accused persons but the said Officer-in-charge did not taken any legal action, then the complainant lodged another complaint to the Superintendent of Police, Purulia but with same fate, then the complainant under compelling circumstances is filing this complaint before the Ld. Court for appropriate reliefs under the law.
