In producing herewith the accused person namely Gojen Mahato @ Bibek (43 Yrs), S/O-Lt-Mathan Mahato of Vill-Bhurshu, PS-Baghmundi, Dist-Purulia along with seized articles 1) 10 (Ten) liter ID Liquor containing in a white plastic jerican, 2) 11 (Eleven) Pcs Plastic Glasses which were seized under proper seizure list duly signed by the witness.

Act which were seized under proper seizure list duly signed by the witnesses. All seized articles were labeled properly in presences of witness and accused person. Hence I arrested the above noted person at 18:55 hrs after maintaining all formalities and guidelines regarding arrest. I offered him medical treatment but he refused.

The above noted arrested accused person namely Gojen Mahato @ Bibek (43 Yrs), S/O-Lt-Mathan Mahato of Vill-Bhurshu, PS-Baghmundi, Dist-Purulia committed an offence U/S- 46 A (c) B.E. Act 1909 for unauthorized possession and selling of ID Liquor from his sole possession.
