Purulia selling illicit liquor in his out house. Accordingly I, along with force namely (1) C/ 2622 Kartick Ghosh (2) C/ 2669 Prabir Singha Mahapatra both of Bandwan PS left for Pargela Village to work out the said source information vide Bandwan PS Spl. C.C No. 90/21, Dtd-07/10/21.
