I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act-2007, to the effect that Bangshi Majhi S/O Late Hagu Majhi Vill- Baisnabdih, Dist- Purulia was enjoying electricity illegally by by-passing the Single Phase Energy Meter (SI No- DDG481350) From its incoming Service Cable through 01-Core PVC wire and he has committed theft of electricity U/S 135(1)/b of the electricity (Amendment act-2007).

On 01.10.2021, I Sri Shibaji Chakraborty, J.E. Gr-II, BARABAZAR CCC, WBSEDCL along with

At About 08:00 A.M., entered into the premises of Bangshi Majhi S/O Late Hagu Majhi Vill- Baisnabdih, Dist- Purulia and inspected his premises at Vill.- Baisnabdih, P.S Barabazar, DIST- Purulia.

During inspection, it was found that Bangshi Majhi S/O Late Hagu Majhi Vill- Baisnabdih, P.S- Barabazar, Dist.- Purulia was enjoying electricity illegally by by-passing the Single Phase Energy Meter (SI No- DDG481350) From its incoming Service Cable through 01-Core PVC wire in his premises at Baisnabdih having connected load 0.071 KVA.

From the above he was using the following arrangements:

01. 01 nos Bulb (60 watts)

I seized the following articles from the said premises:
