On 01.10.2021, I Sri Shibaji Chakraborty, J.E.Gr-II, BARABAZAR CCC, WBSEDCL along with

(1) MD QASIM ANSARI, O.E., BARABAZAR CCC, WBSEDCL

At About 08:31 A.M., entered into the premises of Bharat Gope S/O Ashutosh Gope of Vill- Radhanagar, P.S- Barabazar, Dist- Purulia and inspected his premises at Vill.- Radhanagar, P.S Barabazar, DIST- Purulia.

During Inspection, it was found that Bharat Gope S/O Ashutosh Gope of Vill- Radhanagar, P.S- Barabazar, Dist- Purulia, his family was enjoying electricity illegally hooking from nearest LT OH line with the help of Two core Flexible Wire in his premises at Radhanagar having connected load 0.071 KVA.
