**Sub:** Complaint against Bigyan Sahis (30 Yrs) S/o- Lt. Rahin Sahis of Vill- Amrabera, PS- Barabazar, Dist- Purulia to start a specific case under proper section of Law.

Sir,

In producing here with arrested accused person namely Bigyan Sahis (30 Yrs) S/o- Lt. Rahin Sahis of Vill- Amrabera, PS- Barabazar, Dist- Purulia and seized one white colour plastic jaricane containing approx 17 (Seventeen) liter I.D liquors in which 01 (One) liter taken as sample as per enclosed seizure list.

I, SI Uttam Chatterjee of Barabazar PS do here by lodge this complaint against Bigyan Sahis (30 Yrs) S/o- Lt. Rahin Sahis of Vill- Amrabera, PS- Barabazar, Dist- Purulia. I beg to state that on 07.10.2021 at about 18.55 hrs during my evening mobile duty I received telephonic information that one person was selling I.D liquor in his house at Amrabera village. I was there to verify the credibility of that information and immediately informed the I.C Barabazar PS. As per direction of I.C Barabazar PS myself along with C/- 347 Manas Kumar Pathak & C/- 1182 Santosh Kr. Mahato had been to the said place by Govt. vehicle to work out the information. At about 19.05 hrs I detained one person at Amrabera village under Latpoda G.P who was selling I.D liquors in his house. Seeing the Police party the alleged person and customers were tried to flee away, but I apprehended the seller with the help of the Police party and on being searched I found that the person stoking one white colour plastic jaricane in which containing approx 17 (Seventeen) liter I.D liquors for selling. On demand, he failed to produce any valid documents / License in respect of stoking or selling of I.D liquors. On being asked he confessed his guilt and stated that he was stoking the ID liquors with intent to sell to make his own profit. He disclosed his identity as Bigyan Sahis (30 Yrs) S/o- Lt. Rahin Sahis of Vill- Amrabera, PS- Barabazar, Dist- Purulia. He also admitted that he has no license or any authorization for selling of I.D liquors. Accordingly, I seized one white colour plastic jaricane in which containing approx 17 (Seventeen) liter I.D liquors after preparing proper seizure list and put label on the seized articles in presence of witnesses in which 01 (One) liter taken as sample which were also duly labeled by me and also took signature of the accompanying witness on seizer list and label as well as accused person also. The seizure and label was done in between 19.25 hrs and 20.05 hrs.

Thereafter, I secured arrest the accused person namely Bigyan Sahis (30 Yrs) S/o- Lt. Rahin Sahis of Vill- Amrabera, PS- Barabazar, Dist- Purulia after preparing Memo of Arrest & after observing all other formalities regarding arrest as per Cr.PC and NHRC guideline. I informed him regarding the ground of arrest and his relatives regarding arrest. The arrest was made on 07.10.2021 at 20.35 hrs.

Under the above fact & circumstances I, therefore, pray before you that a specific case may kindly be registered against the arrested accused person namely Bigyan Sahis (30 Yrs) S/o- Lt. Rahin Sahis of Vill- Amrabera, PS- Barabazar, Dist- Purulia under proper section of Law.
