Sir,

In producing herewith with the arrested accused Dharmendra Mishra (40 Yrs) S/o- Lt. Mantu Mishra of Bishanpur, Baramuri, PS- Bhuli, Dist- Dhanbad, Jharkhand seizure list and the seized articles i.e.-

1. One improvised country made one Sutter pipe gun, length about 20.5 cm, butt about 8.8 cm (wooden), barrel 12.5 cm bore 1 cm marked as exhibit "A".
2. One round of 8 mm K.F cartridge, width about 7.5 cm marked as exhibit "B" (Loaded with exhibit "A").

I SI Lakshmi Kanta Pati of Barabazar PS, Dist- Purulia do hereby lodged this complaint against Dharmendra Mishra (40 Yrs) S/o- Lt. Mantu Mishra of Bishanpur, Baramuri, PS- Bhuli, Dist- Dhanbad, Jharkhand. To the effect that on 08.10.2021 Duty officer ASI Partha Sarathi Bose received an information that unknown suspicious peoples were coming towards Barabazar from Purulia side may carrying arms with intent to commit offence at Barabazar area. Accordingly, the matter was diarized vide GDE No- 442 Dtd. 08.10.2021 at 20.05 Hrs and informed the same in toto to I.C Barabazar PS and as per direction of I.C Barabazar PS myself along with ASI Manas Kumar Pan, C/- 111 Samulal Tudu & C/- 1494 Manas Mukherjee left PS to work out the information vide Barabazar PS GDE No- 443 & Spl. C.C No- 116/2021 Dtd. 08.10.2021. We took investigation kit box and others electronic gadgets. We used PS vehicle No- WB 56C 0019.

At about 20.45 hrs we reached at Barabazar Namopara and started NAKA checking as per order of I.C Barabazar PS. At about 21.05 hrs found one person coming from Gorsai morh side and reached nearby NAKA point in front of Hanuman Mandir. After seeing the Police party he tried to flee away but somehow we managed to apprehend him. I asked him about his identity and purpose of moving there. He disclosed his identity as Dharmendra Mishra (40 Yrs) S/o- Lt. Mantu Mishra of Bishanpur, Baramuri, PS- Bhuli, Dist- Dhanbad, He failed to answer the purpose and identified himself as noted above. His body language was shattered. I told him that he may search me and my team because we will search him now as we have an information regarding possession of illegal firearms. He declined to search us. Accordingly, I started searching him properly and found one improvised pipe gun kept in his left waist under pant & shirt. After that it was unloaded the gun and found one round ammunition inside this gun. Asked him for valid license of the gun which he was carrying with him. He failed to produce any documents/license and cannot give any satisfactory answer about possession of the arms. On interrogation he stated that he along with 02 others came from Dhanbad side by a motorcycle intend to commit offence against property at Barabazar market in this time of Durga Puja period. Accompanied 02 persons drop him near the river side at Barabazar with a direction to rekey at market area with intent to commit offence.

On being searched carefully and alertness found on firearms kept within his left waist under the pant & shirt inside the pants. After removing and unloading the arms & ammunition taking measurement as (i) one improvised country made one Sutter pipe gun, length about 20.5 cm, butt about 8.8 cm, barrel 12.5 cm bore 1 cm (ii) Ammunition width about 7.5 cm. Accordingly, I seized the same under proper seizure list and labelled in presence of the witnesses, took the help of an investigation kit box for this purpose. I also sealed the same at said place. I searched local people but nobody turned up as a witness during the search and seizure. The process of seizure took place in between 22.15 hrs and 22.55 hrs then arrested him after obtaining all rules of arrest at 23.15 hrs. Issued memo of arrest, informed him regarding the ground of arrest.

Held a local enquiry in and around the P.O to collect further information about the culprits. Then we left the place with arrested accused, seized articles for Barabazar PS to take further actions as per provision of law.


I came to PS, prepared this letter of complaint and submitted it to I.C Barabazar through duty officer to start a case under proper section of law against the arrested accused Dharmendra Mishra (40 Yrs) S/o- Lt. Mantu Mishra of Bishanpur, Baramuri, PS- Bhuli, Dist- Dhanbad, Jharkhand and to arrange its investigation.
