Sir,

In producing herewith the 05 (Five) arrested persons namely (i) Bhaskar Mahato (38 Yrs) S/o- Lt. Bhim Mahato (ii) Chhutulal Mahato (56 Yrs) S/o- Lt. Paran Mahato (iii) Kalachand Mahato (55 Yrs) S/o- Lt. Padmalochan Mahato (iv) Anil Sahis (59 Yrs) S/o- Lt. Paban Sahis all are of Vill- Jilling, PS- Barabazar, Dist- Purulia & (v) Suchand Mahato (42 Yrs) S/o- Lt. Sahebram Mahato of Vill- Talpat, PS- Bandwan, Dist- Purulia and one white colour Bolero Pick Up van having registration No- WB-55-9901 along with all connected papers and seizure list.

I beg to state that today i.e. 11.10.2021 morning at about 09.35 hrs I.C Barabazar PS received an information from local VP Madan Mahato that in a Bull fight at village Chata Tanrd Khejuradih near Jilling village under Barabazar PS 02 peoples sustained injury and arrangement is being made to shift them at Bari BPHC. This matter was diarized vide Barabazar PS GDE No- 584 Dtd. 11.10.2021. As per instruction of duty officer myself along with force left for Jilling as I was on mobile duty.

At about 10.15 hrs I reached Chata Tanrd Khejuradih near Jilling village and found at 22.984400, 86.532523 a village field is situated. At that field Bull Fight (KARA LORAI) is organized by (i) Bhaskar Mahato S/o- Lt. Bhim Mahato (ii) Chhutulal Mahato S/o- Lt. Paran Mahato (iii) Kalachand Mahato S/o- Lt. Padmalochan Mahato (iv) Anil Sahis S/o- Lt. Paban Sahis (v) Biswanath Mahato S/o- Kalachand Mahato (vi) Ashutosh Mahato S/o- Mariram Mahato all are of Vill- Jilling, PS- Barabazar, Dist- Purulia & (vii) Suchand Mahato S/o- Lt. Sahebram Mahato of Vill- Talpat, PS- Bandwan, Dist- Purulia & (viii) Rohit Mahato S/o- Not known of Vill- Dandudih, (ix) Marshal Hansda S/o- Not known of Vill- Kanku, both of PS- Kamalpur, Dist- East Singhbhum, Jharkhand and others. This information I received from VP Uttam Mahato & VP Madan Mahato, they are present at the place.

I found that after the incident of injury etc. bull fight was discontinued by the people. There was a big hole near the field where the programme was going on. It was surfaced that the above noted persons organized the event without any permission in an un-law full manner. People from different places with their bulls gather there to take part in the event. In course of the event one bull during fight suddenly rushed towards people and assaulted 02 persons namely (i) Jaba Mahato (45 Yrs) S/o- Lt. Chhutu Mahato of Vill- Dandudih, PS- Kamalpur, Dist- East Singhbhum, Jharkhand & (ii) Sasadhar Mahato S/o- Lt. Kenaram Mahato of Vill- Laka, PS- Barabazar, Dist- Purulia. Subsequently, the bull and these 02 persons fall into the big hole situated at the side of the field. The animal and human both sustained injuries. Both the persons were shifted to Boro Hospital. Jaba Mahato was declared death by the Hospital authority latter.

On primary enquiry I found that the event was organized by the above persons without any permission and violated the norms of Covid. As it was an illegal event conducted in a negligent manner inviting the possibilities of death or any subsequent damaged; I raided the houses of organizers. From their respective houses I arrested the accused persons namely (i) Bhaskar Mahato (38 Yrs) S/o- Lt. Bhim Mahato (ii) Chhutulal Mahato (56 Yrs) S/o- Lt. Paran Mahato (iii) Kalachand Mahato (55 Yrs) S/o- Lt. Padmalochan Mahato (iv) Anil Sahis (59 Yrs) S/o- Lt. Paban Sahis all are of Vill- Jilling, PS- Barabazar, Dist- Purulia & (v) Suchand Mahato (42 Yrs) S/o- Lt. Sahebram Mahato of Vill- Talpat, PS- Bandwan, Dist- Purulia. I Issued Memo of Arrest and observed all

formalities regarding arrest. They never took reasonable care and caution to avoid any mischief upon life. Their such act caused the death of one person and bodily injury to another. They had the knowledge that it is likely to cause death if the event is not avoided. There is sufficient reason to believe that all of them were having the knowledge that such type of bull fight may cause death. The entire animals were kept under the possession of the organizers. Bull is feroclous animals and if not guarded properly it is a probable danger to human life. Whoever keeps an animal accustomed to attacking humans, it is his/their responsibility to reduce the mischievous propensity. Bulls are the probable danger to human life. Hence, any negligent act is not permissible.

I further requested the arrested persons to produce any valid papers in support of the event. The event was organized with knowledge that it is likely to cause death or bodily injury in case of any negligence.

I seized one vehicle by which the animals were transported by the organizers vide registration No- WB-55-9901 under proper seizure list in presence of witness. Other organizers were found absconding from their respective residences.

I returned to PS and typed this letter. After that I submitted it before I.C Barabazar PS through Duty officer to start a specific case under proper section of law.
