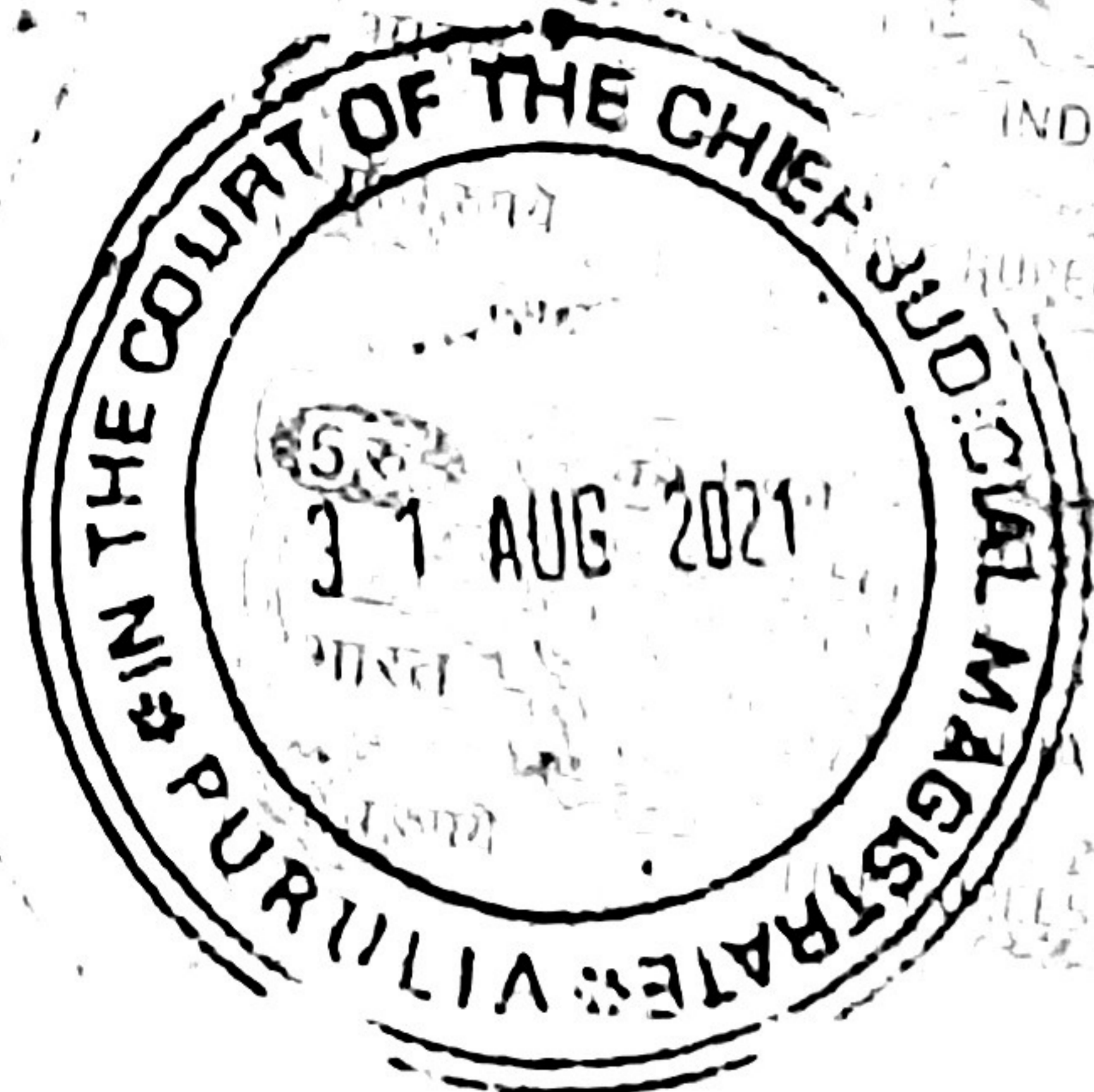

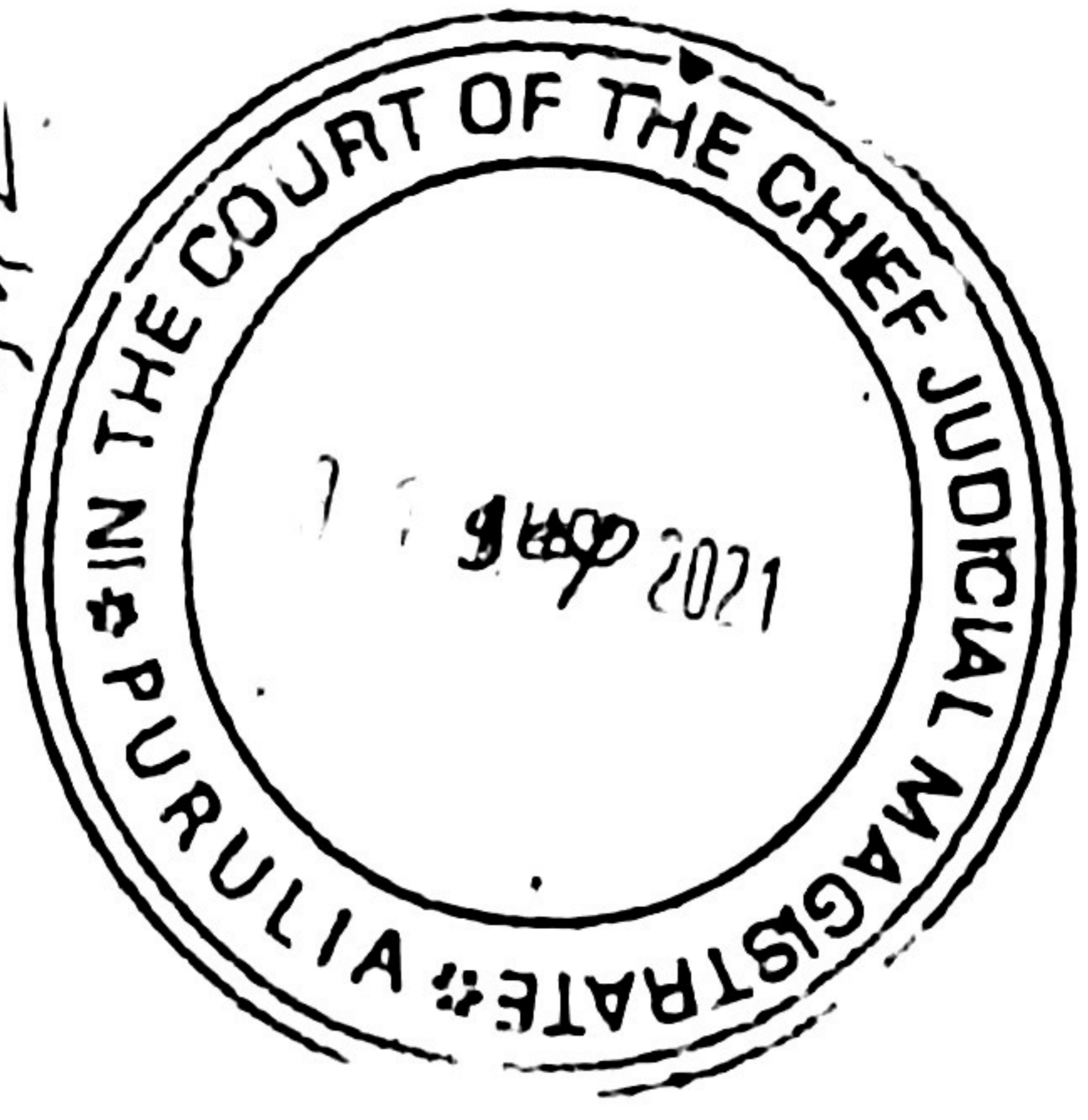

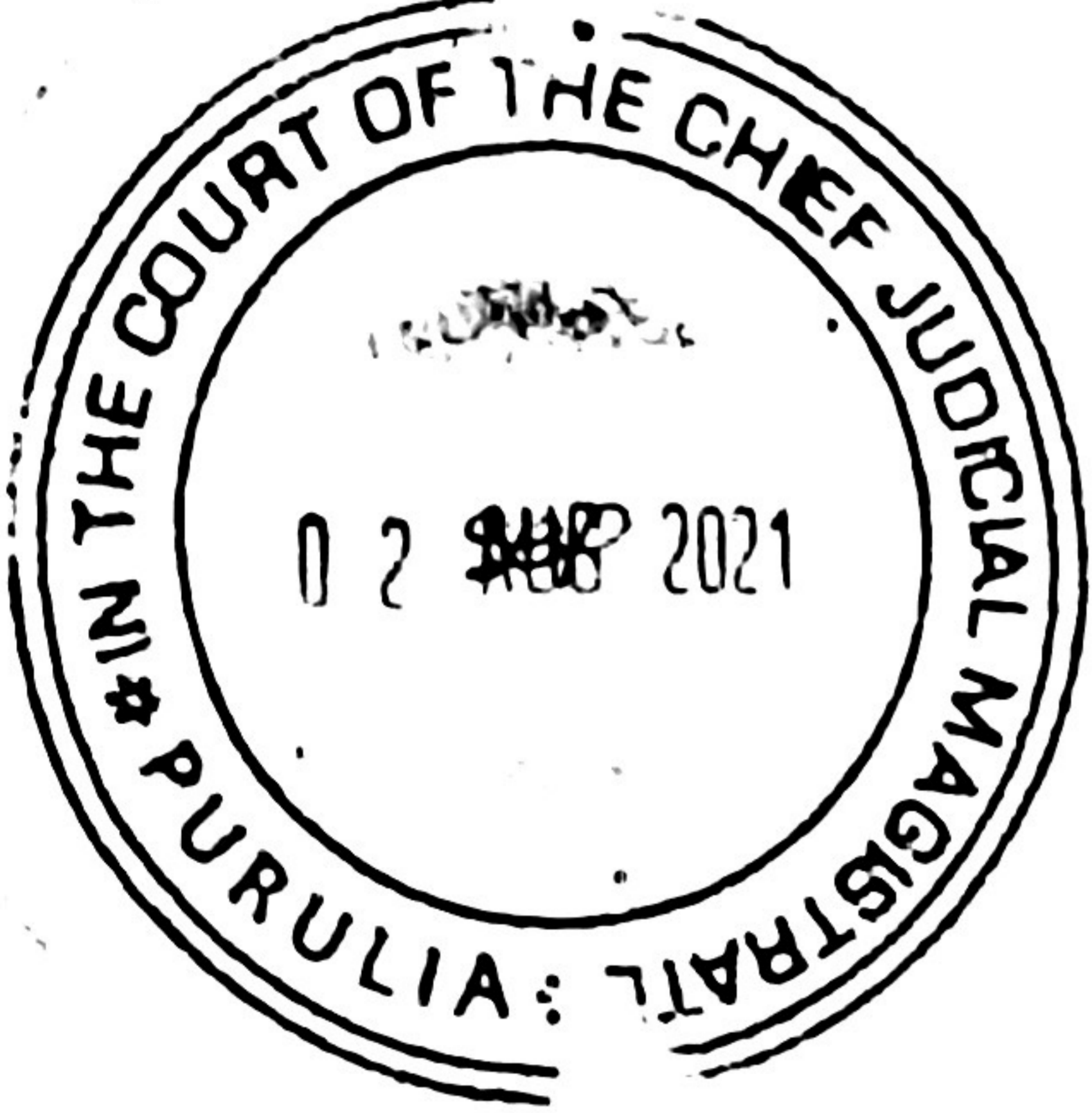

The above named complainant beg to state as follows :

1) That the complainant and the accused both are living in same village (Bazara) under P.S. Barabazar, Dist. Purulia.

2) That on 30.7.2021 corresponding to 13th day of Sraban 1428 B.S. at about 3.00 P.M. when the complainant and her Grand son were seating near her house on the side of Kuli Rasta, Then all on a sudden the Accused (named above) without any reason started abusing the Grand son of the complainant, the complainant and her grand son (Krishan Thakkar) protested of their

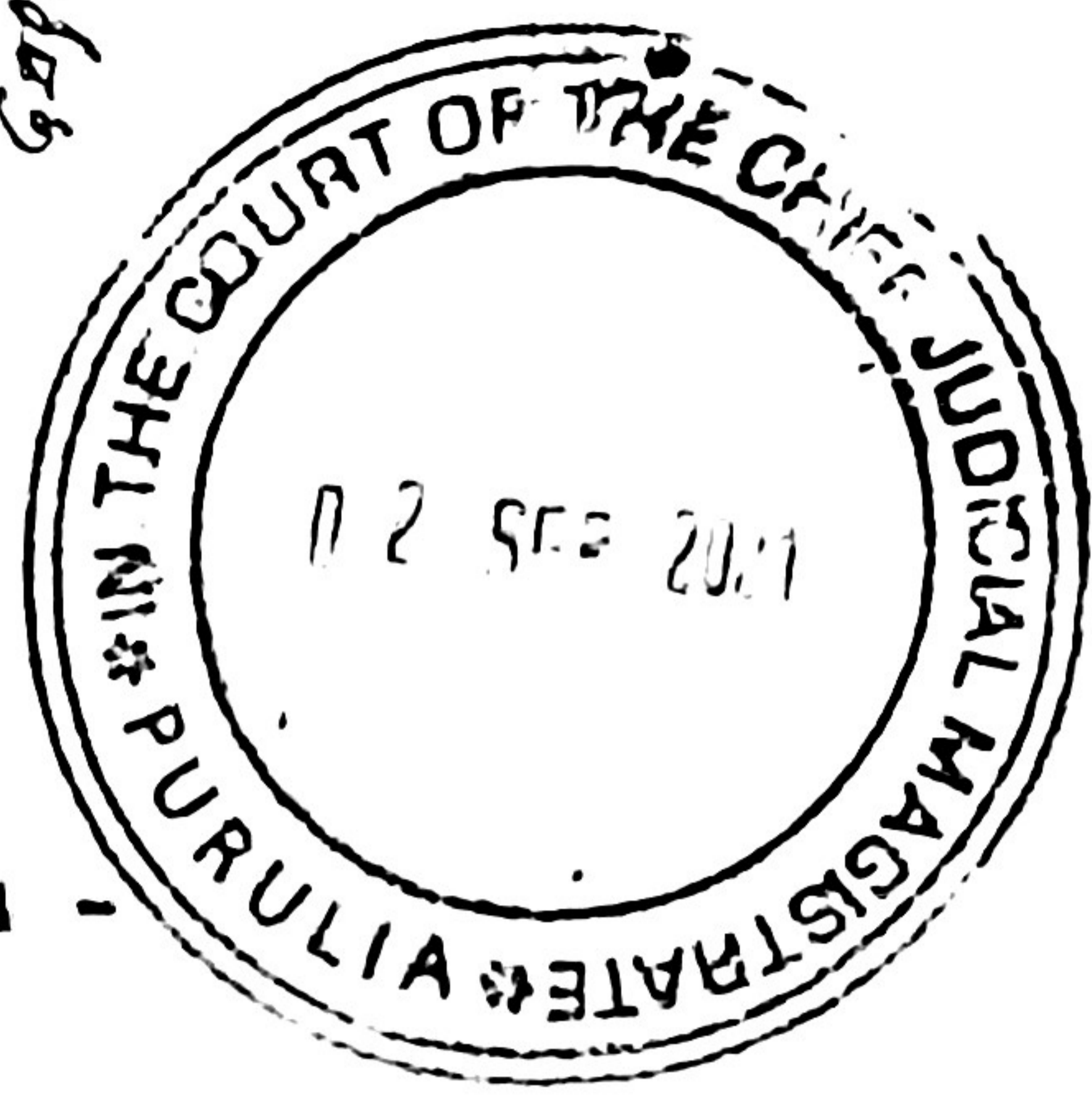
of their illegal act but he did not pay any heed to the request of them. And suddenly the Accd told coming to the Grand son of the complainant that "এটুকি (তার মামলার ব্যাপারে) আমার সন্তানকে আক্রমণ করা হবে আর আমি সন্তান না।"

Thereafter the Accd fell down ^{on} the Grand son of the complainant on Kuliand his neck was pressed by the leg of the Accd, so the tung came ^{out} ~~out~~ with a view to attempt his murder.

Then the complainant makes a noise by saying " Bancho - - - Bancho ". Hearing the news the Ram Karmokar came there and save the Grand son of the complainant from the hands of the Accd. persons. The witnesses named above saw the incident. Then the accd left the place with dire consequence that he will kill the Grand son of the complaint today or tomorrow.

3. That there after the complainant took her Grand son (Kishan Thakkar) to the Barabazar Primary Health centre for his treatment, Medical Officer of Barabazar P.H.C. to see the condition of the patient was not good, so he after necessary treatment referred him to Purulia Sadar Hospital for better treatment,

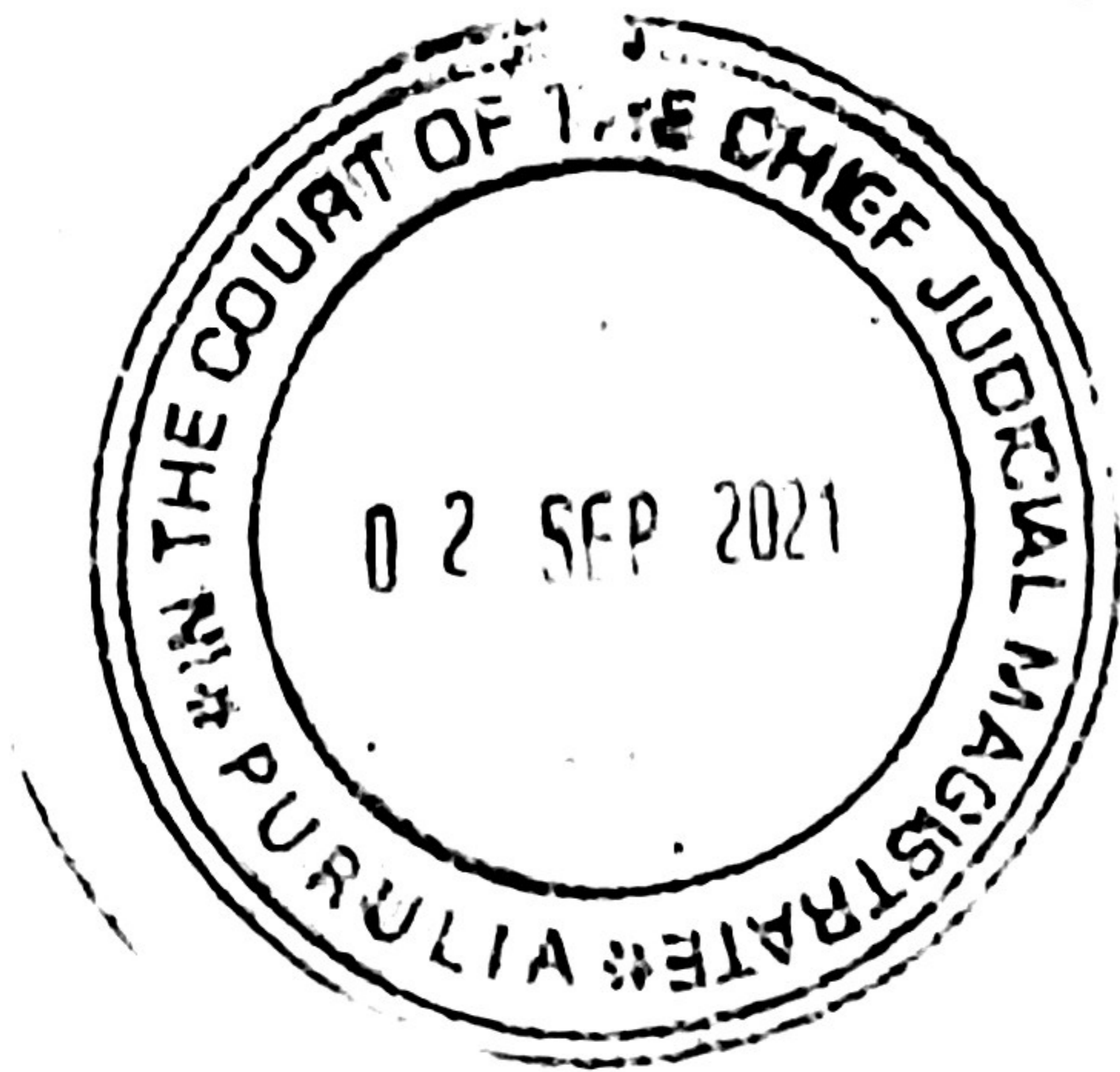

thereafter the complainant had been to Barabazar P.S. and reported the matter to duty officer of Barabazar P.S. against the Accd. The complainant had no any capacity to admit her grand son to Purulia Sadar Hospital. Then she keep her Grand son to her house at Vill. Bazara, and informed the matter to her daughter. And on the following date the mother of the injured came and admitted him to Purulia Sadar Hospital and on dt 02.08.2021 discharged him from Hospital but he is not fit today.

4. That there after the complainant inquired in Barabazar P.S. about her case and she came to learn that no case has been started against the Accd. Then she informed the matter of to S.P. Purulia but off no good.

5. That the complainant is one poor widow and she has no sufficient means to expense of the case for which the complainant seek justice.

It is therefore prayed before Your honour would be pleased to direct the officer-in-charge of Barabazar P.S. for investigation of
