Sub: Prayer for lodged FIR

Sir,

In producing here with 11 (Eleven) arrested persons namely (i) Paitu Mahato (40 Yrs) S/o-Lt. Bhagat Mahato (II) Yudhisthir Mahato (32 Yrs) S/o- Nagen Mahato (III) Angsi Mahato (32 Yrs) S/o- Bhuban Mahato (iv) Sunil Mahato (34 Yrs) S/o- Chelku Mahato (v) Partha Pramanik (20 Yrs) S/o- Sukdeb Pramanik (vi) Sabuj Mahato (32 Yrs) S/o- Niranjan Mahato (vii) Bangshi Mahato (40 Yrs) S/o- Bhuban Mahato (viii) Sandip Mahato (25 Yrs) S/o- Subal Mahato (ix) Manoj Kumar Das (30 Yrs) S/o- Lt. Khagendranath Das (x) Anil Mahato (37 Yrs) S/o- Chelku Mahato (xi) Bijoy Majhi (24 Yrs) S/o- Subhash Majhi all are of VIII- Bishri, PS- Manbazar, Dist- Purulia along with memo of arrest and other relevant papers.

I beg to state that on 25/26.10.2021 night myself along with C/- 1187 Samarkanta Maiti & C/- 1494 Manas Mukherjee were performing night mobile duty at Barabazar PS area. This refers to Barabazar PS GDE No- 1297 Dtd. 25.10.2021 and Barabazar PS C.C No- 2651/2021 Dtd. 25.10.2021. Accordingly, we left PS for performing night mobile duty as well as observe night curfew. At around 03.45 hrs we found that some persons moving almlessly without any valid reason near Barabazar Jaltanki morh under Barabazar PS without wearing face masks and we detained the above noted persons with the help of force and CV who were on duty at that place.

I introduced myself and asked for their identity. They disclosed their identity as noted above. On interrogation these persons stated their identification but failed to give any satisfactory answer for their such type of act for violating govt orders (Night Curfew). I asked them the reason for not wearing face masks in Covid-19 pandemic situation. They failed to explain any valid reason for nonwearing of masks in spite of the government order in public places. Their negligent act is likely to spread infection of disease, dangerous to the life of human beings. All 11 (Eleven) persons also failed to give satisfactory answers for such type of movement in an indiscipline manner. They violated the order duly promulgated by government through public servants and through media etc for prevention of attack from CORONA Virus / COVID-19. They are creating annoyance to the society & violating the govt order vide Memo No- 753/IV-ISS/2M-22/2020 Dtd. 30.09.2021 of the Govt. of WB. Accordingly, I arrested them for Disobedience to order duly promulgated by public servant; after maintaining all rules of arrest. Issued memo of arrest, informed them & their relatives regarding the ground of arrest I.e. as per section 3 of the Epidemic Diseases Act, 1897, provide penalties for disobeying any regulation or order made under the Act. These are according to Section 188 of the Indian Penal Code (Disobedience to order duly promulgated by public servant). At prima facie there was sufficient evidence to secure their detention. They also violated the norms of disaster management. All the process was done in between 03.55 hrs and 05.15 hrs.

After that I left for PS. On arrival at PS I typed this letter of complaint at our PS computer and submitted it to I.C Barabazar PS through duty officer SI Basudeb Acharya for taking necessary action as per law. I handed over all the relevant papers, Arrest Memos.
