Sir,

In producing here with 01 (One) Tractor (SONALIKA) attached with trolley, bearing Registration No- WB 55A 3243 loaded with sand about 100 C.ft (Approx). I beg to state that on 26.10.2021 myself along with ASI Dinabandhu Bauri, C/- 1494 Manas Mukherjee and C/- 1187 Samar Kanta Maity performing evening mobile duty vides Barabazar PS GDE No-1353 Dtd. 26.10.2021 with Govt vehicle. We reached near Taltadr village under Barabazar PS at about 18.15 hrs as per source information and direction received from Duty officer SI Basudeb Acharya. After arriving there we got further information from source about transportation of sand with intent to sell to other destination by illegal means.

l conveyed the same to I.C Barabazar PS again and as per his direction myself along with force started NAKA checking beside the Kancha road at Subal morh near Taltard village under Barabazar PS from 21.05 hrs. At about 21.35 hrs we found one Tractor was coming toward the Naka point and seeing the Police party the driver fled away after keeping the Tractor beside the Kancha road. Chased him but somehow they managed to escape under the cover of darkness. I searched all nearby places but nobody turn up for its ownership. Accordingly, I seized the Tractor (SONALIKA) attached with trolley bearing Registration No- WB 55A 3243 loaded with sand about 100 C.ft (Approx) under proper seizure list. The seizure was done in between 22.05 hrs & 22.35 hrs.

Held an enquiry about the matter and so far information collected it is crystal clear that the driver and the owner of the vehicle collected the sand by illegal mean with intent to make unlawful profit by unlawful collection of sand through illegal manner by unauthorized extraction and removal of mines & minerals. By this way they violated the regulation of procurement of minor minerals. As such there is every reason to believe that the driver and owner of the said tractor with ill motive was transporting the sand illegally without any valid document in support of carrying sand. As such they were doing illegal business activities.

Under the above facts and circumstances, I pray before you that kindly take needful action against the driver and owner of the Tractor (SONALIKA) attached with trolley bearing Registration No- WB 55A 3243.
