Sir,

In producing herewith one seized vehicle i.e Tractor SONALIKA DI/734 having registration no-WB55A/7601, Chasis No-GZQSG732496SM & Engine no-3100DL83D724518F3 fitted with Trolley (without number plate) loaded with sand (approx 100 cft.). The fact of the case in brief is that on 04/10/21 I.S.I Gopal Bhattacharyya of Hura P.S along with, C/959-Babu Ansary, C/496-Praksh Mahato were on day mobile duty on Hura-Bispuria road vide Hura PS CC No-2654 Dtd-04.10.21. During mobile duty on 04/10/21 at about 12:05 hrs received credible source information that the above noted (Tractor) is coming from Kashipur side loaded with sand. After receiving this information we were proceeding towards "Dhabani more" under Hura P.S. When we reached near "Dhabani more" under Hura P.S, found that the above noted (Tractor) was coming from Kashipur side. On seeing the Police party the driver of the said tractor stopped the tractor in a distance at Dhabani more and tried to unload the sand loaded in the said tractor. We rushed to the tractor and the driver then fled away after keeping the tractor near "Dhabani more" at 12:25 hrs. We searched the said tractor and found that the tractor is loaded with sand. I searched for any valid documents in respect of sand loaded in the tractor as well as the valid documents in respect of that tractor but nothing was found. Hence I seized the Tractor Tractor SONALIKA DI/734 having registration no-WB55A/7601, Chasis No-GZQSG732496SM & Engine no-3100DL83D724518F3 fitted with Trolley (without number plate) loaded with sand (approx 100 cft.) under proper seizure list in presence of available witnesses duly signed by them. Thereafter arranging a driver from my source I brought the said tractor to Hura P.S. As such there is every reason to believe that the driver and owner of the Tractor SONALIKA DI/734 having registration no-WB55A/7601, Chasis No-GZQSG732496SM & Engine no-3100DL83D724518F3, fitted with Trolley (without number plate) with ill motive are transporting sand illegally without any valid document in support of carrying sand. So they are liable for offence punishable U/S-379/411/414/120B IPC & 21 (1)(4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against the driver and owner of Tractor SONALIKA DI/734 having registration no-WB55A/7601, Chasis No-GZQSG732496SM & Engine no-3100DL83D724518F3, fitted with Trolley (without number plate) may kindly be started and arrange for its investigation.
