Sir,

In producing herewith one arrested accused person namely Dharmendra Mahto @ Dharma (35) S/o Dasu Charan Mahto of Vill.- Kocho, PS-Silli, Dist.- Ranchi, State-Jharkhand under arrest along with seized articles as per seizer list i.e. approx 03 (three) liters of illicitly distilled liquor (Cholai) in a bladder under proper seizure with label.

I ASI Ramnath Gorai of Tulin OP under Jhalda PS hereby lodged a written complaint against the above noted accused person to the effect that on 07/10/2021 morning myself along with force C/272 Arijit Roy, C/2009 Buddhadeb Dey & C/850 Sujit Mondal all of Tulin OP were performing Naka checking duty at Subranarekha Bridge on Purulia-Ranchi Road vide CC No. 1389 dated 07/10/2021 and Tulin OP GDE No. 183 dated 07/10/2021. At about 13:15 hrs we noticed the above noted person, who was proceeding towards Tulin side on foot from Jharkhand side hanging something in his hand. On suspicious basis we intercepted him and on search I found one rubber made bladder loaded something in it in a plastic bag. On asking he told that the said bladder is loaded with approx 03 (three) liters Cholai i.e. illicitly distilled liquor. On demand he failed to produce any license / authority of the said liquors. On interrogation he also made incoherent statement regarding possession of said liquors and told that he is usually selling the same to the villages in Bengal side illegally. So, finding no any other alternative way I seized the above noted articles from the possession of the accused person and labeled, duly signed by the accused person & witnesses in between 13:35 hrs to 13:55 hrs in which 01 (one) 100 ML bottle of "illicitly distilled liquor (Cholai)" was kept as sample file with label. During interrogation he confessed his guilt as such I arrested him at 14:05 hrs after observing all the formalities as per law issuing memo of arrest as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Dharmendra Mahto @ Dharma (35) S/o Dasu Charan Mahto of Vill.- Kocho, PS-Silli, Dist.- Ranchi, State-Jharkhand u/s-46A (c) of the Bengal Excise Act 1909.
