Sir,

I, ASI-Khageswar Kumar of Jhalda Police station, Dist-Purulia do hereby lodge this complaint to the effect that today i.e. on 30.10.21 at 10:35 hrs. on receipt of a telephonic information regarding obstruction on Jhalda-Baghmundi Road at Jargo more under Jhalda PS, when myself along with R.M./1471-Dipesh Thapa, R.M./1501-Pramod Rai, C/240-Manoranjan Bagti, C/1496-Subal Mahato, and LC/1053-Pratima Chaudhury engaged in Mobile duty Vide Jhalda PS CC No- 4356/21, GDE No- 1177 dated- 30.10.21 and as per direction engaged for implementation of Govt. rules regarding pandemic situation and disaster management plan, we left for Jargo more under PS-Jhalda, Dist-Purulia. After reaching the spot at about 10:45 hrs, we found that Jargo more (Jhalda Baghmundi road) has been blocked by the following persons having been identified by the local source and as well as local police friend at the spot namely (i) Pratima Mahato (43) W/O Gokul Ch. Mahato (ii) Karuna Mahato (54) W/O Bhushan Mahato (iii) Usha Mahato W/O Achintya Mahato (iv) Shrimanta Mahato (29) S/O Nerandra Nath Mahato (v) Jayanti Mahato (47) W/O Kailash Mahato (vi) Rathibala Mahato (37) D/O Lt. Amar Mahato (vii) Uma Mahato (39) W/O Laxmicharan Mahato (viii) Sabitri Mahato (49) W/O Bhajahari Mahato all of Vill-Jargo, PS-Jhalda, Dist-Purulia and 15/20 (approx) unknown others showing agitation on demand of a new drainage channel beside the road on that area and creating pandemonium and causing Traffic congestion and by making inconvenience to public. We requested and subsequently warned several times to remove the obstruction and to regularize the traffic flow. But they disobeyed our order as knowing us police personnel and having no pay heed our order they took dangerous way to obstruct public way. After several warnings, ultimately all the known and unknown persons among the mob who were causing obstruction, withdraw road blocked at about 11:15 Hrs and subsequently dispersed from the area. Though pandemic of COVID-19 outbreak is going on throughout the District of Purulia. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F.W/120/20 dated 22.03.2020 which is extended till 03.05.2020. Later on the order is extended till 30/10/2021. Therefore, they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life and violated Govt rules. So they committed offence and punishable U/S-186/283/188/269/270 IPC and Read with section- 51 Disaster Management Act' 2005.

After arriving at Jhalda PS along with other officer and force I submitted this complaint to start a case U/S-186/283/188/269/270 IPC and Read with section- 51 Disaster Management Act' 2005 against all the aforesaid persons and 15/20 (approx) unknown others.
