Sub : Complaint against miscreants attacked forest personnel while performing duty to
Seize a Tractor bearing no: "WB 55 B 2927" loaded with teak logs felled at
Nowagarh deep Forest areas. (F.I.R)

Sir,

This is to inform you that on dated 25.10.2021 at around 7:30 P.M while performing regular patrolling duty at Nowagarh forest areas, Mouza Nowagarh under Beat: Jhalda PS-Jhalda, I along with my Beat Officer and Forest Guard received an information that some Teak (*Tectona grandis*) tree have been felled at the said forest areas and 1 tractor loading the said forest produce.

After getting the said information we started searching the areas and have found the felled tree branches and stumps of the trees in the said forest areas. We further started searching the loaded vehicle which was used for carriage of the forest produce. After a long search, we have found the tractor bearing no: WB 55 B 2927 which was loaded with felled Teak (*Tectona grandis*) logs near village Bandtar in the the same mouza and driver run away from the tractor.

While we tried to seize the vehicle and logs, some miscreants attacked us whose name is given below:-

1) Name : Sk Faijulla S/O Rabban Kazi Village-Husendih ,P.O-Jhada, P.S- Jhalda (miscreants leader)

2) Name :Hasu Mohommad S/O Umed Khan Village-Husendih ,P.O-Jhada, P.S- Jhalda

3) Name: Md Mister (Driver)

4) Name:Paresh Maji S/O Sukdeb Maji vill:Nowagarh,Po:Jhalda,PS:Jhalda

5)and others

have stooped us, push me and my staffs forcefully from the land away, threat for life and forcefully removed all seized logs from the tractor. While stopping to Md.Foijulla S/O Rabban Kazi Village-Husendih ,P.O-Jhada, P.S- Jhalda (miscreants leader), he pushed me and intentionally pulled tractors side door and one heavy log felled on my right leg and got injury (Medical report attached herewith).

They were such a ferocious motive that they did not listened anything and all seized logs removed from the said tractors.

Meanwhile we have called on for help at local police station i.e. PS: Jhalda and after reaching Jhalda PS team they escorted me and my staffs from that place along with the seized tractor to my Range Office.

In this circumstance I request you to do necessary actions from your end so that the miscreants shall be punished as per law.
