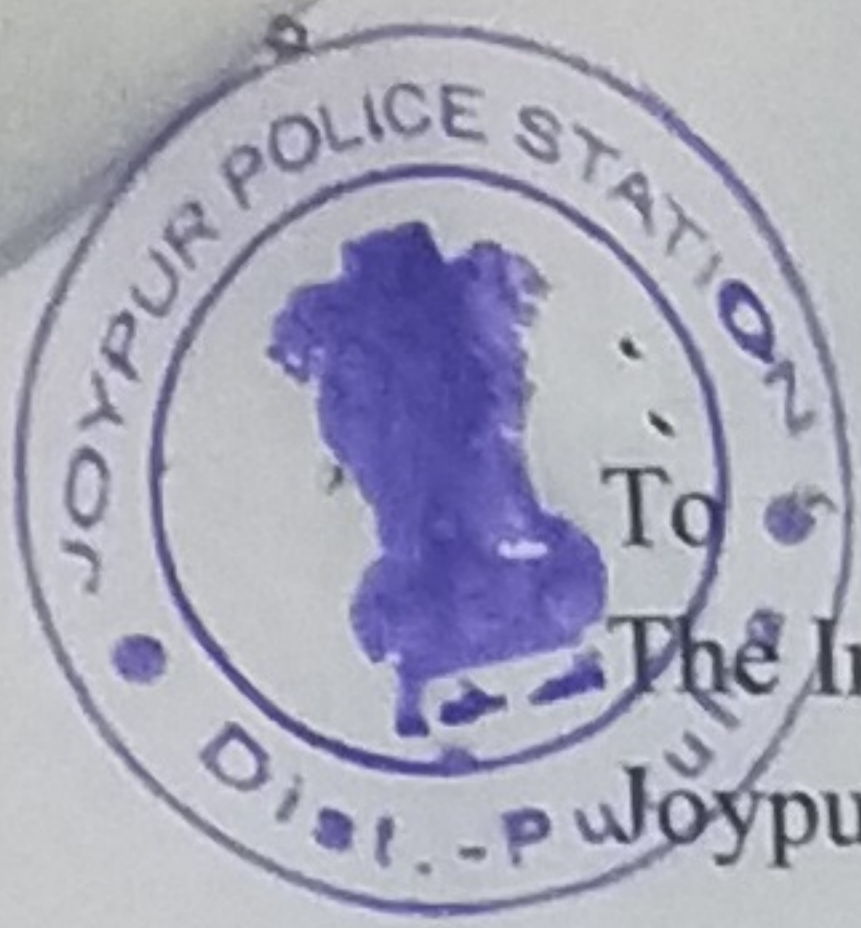

Sir,

In producing herewith one arrested accused person namely Dilip Mahato (22 yrs) S/o-Dhananjoy Mahato of Vill-Gopalpur PS- Jhalda Dist- Purulia, State-WB under arrest along with seized articles as per seizer list i.e. 12 (Twelve) Liter illicit country sprit (Mahula) under proper seizure with label.

I ASI Nisith Ch Das of Joypur PS hereby lodged a written complaint against the above noted arrested accused person to the effect that on today (07/10/2021) at about 14:35 hrs when myself along with C/-1356 Rajib Kundu, C/-985 Lakhan Ch Majhi, NVF/-018 Biswanath Mahato were performing Day mobile duty, as per my source information I reached at Bartard Hattola under Joypur PS and found that the above noted accused person selling illicit country sprit (Mohula) in Bartarard Hattola. On seeing Police persons, he conceal his presence at that place, but on searching we able to trace out him and also to found that 12 (Twelve) Liter illicit country sprit (Mahula) which was kept conceal at Bartard Hattola. On being asked he disclosed his name and address as noted above. On interrogation he stated that he was selling Illicit country spirit liquor to the local people in Bartard village. On demand he failed to produce any valid documents in respect of selling such illicit liquor. So it is reasonable to believe that he was selling the Id liquor illegally without any documents. So I seized the same under proper seizure list in between 15:15 hrs to 15:30 hrs & label duly signed by him and other available witness after taking 300 ML as sample in a separate bottle from the Jarican.

During further interrogation he confessed his guilt as such I arrested him today 07/10/2021 at 15:35 hrs as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific case may kindly be started against the accused person namely Dilip Mahato (22 yrs) S/o-Dhananjoy Mahato of Vill-Gopalpur PS- Jhalda Dist- Purulia, State-WB U/S-46A (c) of the Bengal Excise Act 1909.
