In producing herewith the one seized vehicle (red colour tractor with trolley loaded with sand) Having Eng No- NKB2EMJ0145 & Chassis No: MBNABAEXPKJC04638, attached with

The nub of the fact in a nutshell is that today (30/10/2021) while I, along with C/120 Sandip Kumar & C/1389 Debnath Roy, left Baglata Investigation Centre to perform evening mobile duty vide Baglata I.C. GDE No. 874, dated 30.10.21, in Baglata I.C. area. During my evening mobile duty I, received a tip off at 17:25 hrs that, on the bank of the Izari River at Sidhih village under Joypur PS, some persons were illegally lifting sand from the river transporting the same by a suspicious tractor to run clandestine business. Subsequently, I along with force proceeded toward Ijri river bank to work out the tip off. While, I along with force arrived near Ijri river bank at Sidhi village and found that, some persons are illegally lifting sand in to a tractor attached trolley.

I, along with force proceeded to intercept the vehicle but seeing the police persons the driver and others left the Red Colour Tractor without any number plate having Eng No-NKB2EMJ0145 & Chassis No: MBNABAEXPKJC04638, attached with trolley loaded with sand and fled away. Accordingly, I tried to find out the name & address of the driver and owner of the tractor but in vain.

During enquiry, it is ascertain that the driver of the said tractor loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business by transporting the same at Jharkhand State. So, it is reason to believe that they in cahoots with the owner of the vehicle procured the said sand from IJri River near Sidhi village side by fraudulently means or theft by any means for transporting the same at Jharkhand State to run clandestine business. As per source information, they are habitual offender of this crime, as they have been engaged in the said illegal sand leafing business since long, behind the eyes of the administration.

So, I seized the said red colour tractor without any reg- Number plate, having Eng No-NKB2EMJ0145 & Chassis No: MBNABAEXPKJC04638, attached with the trolley loaded with sand under proper seizure list in presence of available witnesses duly signed by them. Thereafter I brought the seized tractor to Joypur PS.

Under above fact and circumstances kindly take lawful action against the Owner & Driver of the tractor having Eng No- NKB2EMJ0145 & Chassis No: MBNABAEXPKJC04638, as they committed offence U/S 379/411/413/414/120B IPC and 21 (i)(4) of Mines and Minerals (R&D) Act - 1957.
