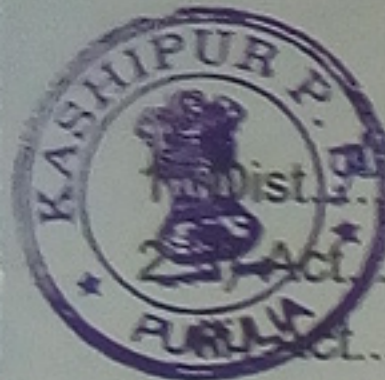

(2) Mahindra 575 DI XP Plus (Red Colour) Tractor without Registration No having Engine No NML2GCJ0323, Chassis No MBNGAALXCMNL00313 along with trolley loaded with approx 55 CFT Sand. (3) Sonalika (Blue Colour) Tractor having Registration No WB 55A/7150 along with trolley loaded with approx 50 CFT Sand. The nub of the fact in a nutshell is that today on 03.10.21 at 09.35 hrs. I SI Kalyan Kr Sakha of Kashipur PS along with (i) C/2169 Prasanta Lohar and (ii) C/1208 Suresh Hansda both of Kashipur PS, Dist - Purulia, left the PS for performing special mobile duty at Kashipur P.S area vide Kashipur P.S GDB No 96 Dtd - 03.10.2021 and C.C No. 2421/21 Dtd. 03.10.2021. During my mobile duty, I received a tip off at 10.15 hrs. that some persons were loading seven tractors with sand from the river bed of Darkeswar River near Shyambathan village under Kashipur P.S. Subsequently, I along with force moved to the spot. We kept the vehicle on the bank of river and proceeded towards the spot by foot. We came to find that few persons were loading sand in the attached trolleys of said tractors. Seeing the Police party, those persons leaving the tractors (loaded with sand in the attached trolleys) at Darkeswar River and fled away from the spot. We rushed to the Tractors and detained the said tractors. We searched the said tractors and found that the tractors is loaded with sand and also searched surrounding but could not trace out the persons & drivers of said offending Tractors. Hence, seized the above noted tractors along with trolleys loaded with sand as noted above and brought the said seized tractors to Kashipur PS. As there is every reason to believe that the driver and owner of the said tractors with ill motive were transporting sand illegally without any valid documents in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owners and drivers of above noted tractors along with the trolleys for investigation.
