In producing herewith, 03 (Three) tractors i.e. (1) Trackstar 536 (Blue Colour) tractor without registration No, having Engine No NLJ2DEJ0011, Chassis No M9KATABABLVJ01634 along with trolley (without number plate) loaded with sand approx 40-45 Cft (2) Mahindra B 275DI (Red Colour) tractor having registration No. WB81/1618 along with trolley (without number plate) loaded with sand approx 35-40 Cft (3) Mahindra 265 Dl (Red Colour) tractor without registration No, having Engine No and Chassis No. NGNL01790 along with trolley (without number plate) loaded with sand approx 40.45 Cft before you.

The nub of the fact in a nutshell is that today on 04.10.2021 at 07.35 hrs. I PSI Gourango Roy of Kashipur PS along with (i) C/716 Achinta Majee and (ii) NVF/678 Basudeb Char both of Kashipur PS, Dist -Purulia, left the PS for performing mobile duty at Kashipur P.S area vide Kashipur P.S GDE No 127 Dtd -04.10.2021 and C.C No. 2430/21 Dtd. 04.10.2021. During my mobile duty, I received a tip off at 08.25 hrs. that some persons were loading three tractor with sand from the river bed of Darkeswar River near Jagannathdih Village under Kashipur P.S. Subsequently, I along with force moved to the spot. We kept the vehicle on the bank of river and proceeded towards the spot by foot. We came to find that few persons were loading sand in the attached trolley of said tractors. Seeing the Police party, those persons leaving the tractors (loaded with sand in the attached trolley) at Darkeswar River and fled away from the spot. We rushed to the Tractors and detained the said tractors. We searched the said tractors and found that the tractors are loaded with sand and also searched surrounding but could not trace out the persons & drivers of said offending Tractors. They also violating the order notification vide Memo No - VI/430 (Part - VIII)/257/C/M/17 Dtd 02.07.2021 of DM and Collector Purulia, regarding ban of sand lifting from Riverbed. Hence, seized the above noted tractors along with trolley loaded with sand and brought to Kashipur PS. As there is every reason to believe that the driver and owners of the said tractors with ill motive were transporting sand illegally without any valid documents in support of carrying sand and violating the Govt, order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owners and drivers of above noted tractors along with the trolley and unknown others for investigation.
