Sub: To lodge FIR against owner and driver of Mahindra B 275 DI (Red Colour) tractor having registration No WB 81/2421 along with trolley (without number plate) loaded with sand approx 55-60 Cft

In producing herewith, 01 (One) tractor i.e. Mahindra B 275 DI (Red Colour) tractor having registration No WB 81/2421 along with trolley (without number plate) loaded with sand approx 55-60 Cft before you.


The nub of the fact in a nutshell is that today on 06.10.2021 at 09.35 hrs. I PSI Gourango Roy of Kashipur PS along with (i) C/416 Sahadeb Hansda and (ii) C/726 Dipankar Mahato both of Kashipur PS, Dist - Purulia, left the PS for performing mobile duty at Kashipur P.S area vide Kashipur P.S GDE No 223 Dtd - 06.10.2021 and C.C No. 2455/21 Dtd. 06.10.2021. During my mobile duty, I received a tip off at 10.55 hrs. that some persons were loading one tractor with sand from the river bed of Darkeswar River near Siulibari Village under Kashipur P.S. Subsequently, I along with force moved to the spot. We kept the vehicle on the bank of river and proceeded towards the spot by foot. We came to find that few persons were loading sand in the attached trolley of said tractor. Seeing the Police party, those persons leaving the tractor (loaded with sand in the attached trolley) at Darkeswar River and fled away from the spot. We rushed to the Tractor and detained the said tractor. We searched the said tractor and found that the tractor is loaded with sand and also searched surrounding but could not trace out the persons & drivers of said offending Tractor. They also violating the order notification vide Memo No - VI/430 (Part - VIII)/257/C/M/17 Dtd 02.07.2021 of DM and Collector Purulia, regarding ban of sand lifting from Riverbed. Hence, seized the above noted tractor along with trolley loaded with sand and brought to Kashipur PS. As there is every reason to believe that the driver and owners of the said tractor with ill motive were transporting sand illegally without any valid documents in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owner and driver of above noted tractor along with the trolley and unknown others for investigation.
