Respected Sir,

In producing herewith arrested accused Dharmendar Chowdhury (25 Years), S/O Ukil Chowdhury of vill – Pathuriagora, PS - Kashipur, Dist - Purulia along with seized articles, I beg to report that on 07.10.2021 at 18.15 hrs during my mobile duty received telephonic information that the above noted accd selling liquor at Pathuriagora village in his house. Accordingly I, ASI Santosh Sardar along with C/117 Arpan Mandal and NVF/693 Jayanta Sing Sardar reached at Pathuriagora village in his house of the above noted accused at 19.05 hrs and found that one person was selling Liquor in his house. After seeing police party liquor customers fled away from the spot. On demand the seller failed to produce any valid document for selling liquor in his possession. So the above noted accused has committed an offence u/s - 46(A)(c) B.E. Act 1909 Amended up-to date. During search I found (1) 10 (Ten) Bottle CS liquor brand as "Dil Khush" 300 ML each out of this 19 bottles 01 bottle took as sample with sealed and labeled (2) One white colour jarikin loaded with 05(Five) liters ID liquor (Chullu) out of seized ID liquor 300 ml taken out in a separate container as sample with sealed and labeled. I also seized and labeled all the seized articles at the spot in presence of accused person and witnesses. Accordingly I arrested the above noted accused person at 19.35 hrs u/s - 67 Bengal Excise Act 1909 and informing him the ground of arrest and I prepared arrest memo after maintaining all arresting rule as well as I brought him to P.S. with above noted seized articles.

Therefore I pray before you that kindly arrange to start a specific case u/s 46(A)(c) B.E. Act 1909 against arrested accused Dharmendar Chowdhury (25 Years), S/O Ukil Chowdhury of vill – Pathuriagora, PS - Kashipur, Dist - Purulia and arrange for its investigation.
