Total permanent loss unearthed till dated is Rs 56500 /- (Rs Fifty Six Thousand Five Hundred) only


There has been delay in filing the FIR due to the departmental investigation and progression of the case and reconciliation of the final amount for the convict.


So, cognizance of the case may be taken, FIR may kindly be lodged and investigation into the case may kindly be conducted at the earliest with intimation of development of the case to this office.
