I, ASI Sukhendu Mondal of Kenda PS, Dist- Purulia in producing herewith one arrested accused person namely Sunil Mahato (62 Yrs), S/o - Lt. Shasadhar Mahato of Vill- Punura, P.S - Kenda, Dist- Purulia with seized articles i.e. 1) One white colour jarican containing Approx 18 (Eighteen) Ltrs. ID Liquor 2) 07 (Seven) pcs plastic glasses (3) Approx 370 ml ID liquor as sample which was collected from seized articles in Sl No-01 & kept in a bottle which were seized under proper seizure list.

I beg to submit that today (07-10-2021) during special raid duty acting on a secret source information myself along with (1) C/181 Rabban Sekh, (2) NVF/23 Rabindranath Mahato, (3) H/G-1933 Lakhindar Mura of Kenda PS conducted raid in the house of the accused person namely Sunil Mahato at about 16:15 hrs and found that he was keeping and selling of ID liquor to the others at his residential house at Punura villge. Seeing the Police party, all customers fled way but we managed to apprehend the accused person. On being asked he failed to produce any valid licence /documents in respect of storing and selling of ID liquor. As such I seized 1) One white colour jarican containing Approx 18 (Eighteen) Ltrs. ID Liquor 2) 07 (Seven) pcs plastic glasses (3) Approx 370 ml ID liquor as sample which was collected from seized articles in Sl No-01 & kept in a bottle which were seized under proper seizure list in presence of witnesses and duly signed by them and also arrested the above noted person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labelled in presence of witnesses. I also arranged to inform his family member about the ground of arrest and place of detention.

Under the above fact and circumstances, I therefore pray that a specific case may kindly be start against Sunil Mahato (62 yrs), S/o - Lt. Shasadhar Mahato of Vill- Punura, P.S - Kenda, Dist-Purulia as per proper section of law.
