I, ASI Prasanta Sanyal of Kenda PS, Dist- Purulia in producing herewith the following accd. Persons namely (i) Ranjit Mahato (24 Yrs.), S/o- Nantu Mahato of Vill- Baliguma, PS- Kenda, Dist- Purulia (ii) Rabi Rajwar (28 Yrs.), S/o- Sitaram Rajwar of Vill- Kuruptopa, PS- Kenda, Dist- Purulia (iii) Sushen Majhi (19 Yrs.), S/o- Manjura Majhi of Vill- Bari (Majhigura), PS- Manbazar, Dist- Purulia (iv) Bablu Sahis (31 Yrs.), S/o- Adhar Sahis of Vill- Gopladih, PS- Tamna, Dist- Purulia (v) Dhiren Mahato (39 Yrs.), S/o- Saktipada Mahato of Vill- Chirka, PS- Purulia (M), Dist- Purulia (vi) Sudhan Mahato (28 Yrs.), S/o- Naren Mahato of Vill- Takria, PS- Barabazar, Dist- Purulia and (vii) Sarkar Majhi (55 Yrs.), S/o- Lt.Fuchu Majhi of Vill- Parkidih, PS- Arsha, Dist- Purulia do hereby lodge a written complaint against them to the effect that today on 07/10/2021, as per direction while I along with C/1535 Dharami Dhar Mandal NVF/0826 Ramchandra Mahato & HG/1423 Banamali Manki both of Kenda PS engaged in evening mobile duty at Kenda PS area and while we reached near Kenda Bazar at about 17.45 hrs. found that the above noted persons along with others moving here and there without wearing of mask during this pandemic situation and not maintaining the social distancing and on seeing the police parties some of them fled away and we are able to arrest the above noted accused persons, as there is every possibility that the above noted accused persons moving here and there without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of disease dangerous to human life and violated Government rule. I offered them for medical checkup, but they denied stating themselves ok, hence, I could not.

Therefore, I pray that a specific case may kindly be start against above noted arrested accused person as per proper section of law.
