I, SI Subhendu Sekhar Bera of Kenda PS, Dist- Purulia in producing herewith one arrested accused person namely Bholanath Kisku (28 Yrs), S/o – Nirmal Kisku of Vill- Bamungora, P.S – Kenda, Dist Purulia with seized articles i.e. 1) 02 (Two) numbers of black colour rubber tube containing Approx 40 ltrs ID Liquor (20 Ltrs ID Liquor in each tube) 2) One white colour polythin bag (3) One Black & red colour Hero passion Pro motor cycle bearing Reg. No. JH 05BR 9238 (4) Approx 375 ml ID liquor as sample which was randomly collected from seized articles in SL No-01 & kept in a bottle which were seized under proper seizure list.

I beg to submit that today (19-10-2021) at about 19:15 hrs while myself along with force (1) C./315 Mir Kurban, (2) NVF/0826 Ram Ch. Mahato both of Kenda PS were performed naka checking duty at Keshya more found that the above noted accused person was coming from Turang village side with one M/cycle bearing Regd. No. JH 05 BR 9238 loaded with Two number of black colour big size tube. Accordingly myself along with force stopped him and on being search found approx. 40 ltrs of ID Liquor were kept in those tube. On being asked he failed to produced any valid licence/documents in respect of carrying of ID Liquor as such I seized 1) 02 (Two) numbers of black colour rubber tube containing Approx 40 ltrs ID Liquor (20 Ltrs ID Liquor in each tube) 2) One white colour polythin bag (3) One Black & red colour Hero passion Pro motor cycle bearing Reg. No. JH 05BR 9238 (4) Approx 375 ml ID liquor as sample which was randomly collected from seized articles in SL No-01 & kept in a bottle which were seized under proper seizure list in presence of witnesses and duly signed by them and also arrest the above noted person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labelled in presence of witnesses. I also arranged to inform his family member about the ground of arrest and place of detention.

Under the above fact and circumstances, I therefore pray that a specific case may kindly be start against Bholanath Kisku (28 Yrs), S/o – Nirmal Kisku of Vill- Bamungora, P.S – Kenda, Dist-Purula as per proper section of law.
