In producing herewith the accused namely Nitish Kumar Mahato (25 Yrs.), S/o-Prafull Mahato of Vill- Hurumbil, PS- Kamalpur, Dist- East Singbhum, Jharkhand and also seized vehicles (Pik-up van) bearing Registration No. JH05CQ-5318, loaded with appx 100 Cft. sand. The fact of the case in brief is that on 26/10/2021 I along with C/ 315 Mir Kurban and NVF- 826 Ramcharan Mahato of Kenda PS were performing evening mobile duty. During mobile duty on 26/10/2021 at about 18.25 hrs. when we reached near at Mahespur village found that the above noted Pik-up van was coming from Maheshpur village side under Kenda PS. On seeing the Police party driver of the said vehicle stopped his Pik-up van in a distance and he tried to fled away after keeping the Pik-up van near at Mahespur village but we manage to detain the driver of the said Pik-up van. On demand the driver of the said vehicle failed to produce any valid documents in respect of the said Pik-up van and loaded sand. It ascertained that the owner and driver of the said Pik-up van loaded the said sand by illegal manner for selling the same to make profit by dishonestly in a clandestine business. So seized the Pik-up van bearing Reg. No. JH05CQ-5318 loaded with sand under proper seizure list in presence of available witnesses duly signed by them and also arrested the driver of the said Pik-up van after preparing memo of arrest duly signed by the accused driver. I also informed him regarding ground of arrest and arranged to inform his relatives. Thereafter arrange driver from my source and brought the Pik-up van at Kenda PS. So there have sufficient reason to belief that driver and owner of the said seized Pik-up van procured the said sand by fraudulently means or theft by any means for transporting the same to clandestine business.

Under the above facts and circumstances kindly take lawful action against the owner and arrested driver of the Pik-up van having Registration No. JH05CQ-5318 loaded with sand 1.
