

The above named complainant begs to state as follows:-

1.) That the complainant and the accused persons residing in the same village of Begunkudor P.S. Kotshila District Purulia on 25/7/2021 (Sunday) at about 9:30 AM while I was at my Fooding shop alone at that point of the time the accused persons namely Hiren Karmakar Jiten Karmakar both Son's of Late Janaki Karmakar, Piyush Karmakar S/O, Late Ajoy Karmakar, Muchiram Swarnakar S/O, Nepal Swarnakar, Rahul Karmakar S/O, Gopinath Karmakar, Gopal Karmakar S/O, Late Naru Karmakar, Surja Sen S/O, Late Gour Sen Bhaju Das S/O, Netai Das, Dibakar Kaibartya S/O Robi Kaibartya, Tikua Kuizy S/O, Surja Kuizy, and Amitabha Karmakar S/O, Debdas Karmakar all are resident of Village + P.O. Begunkudor, P.S. Kotshila, District Purulia gherawed me and my shop being armed with Lathi, Iron Rod, Sabal etc... and started filthy Language towards me. All the Accused Persons started giving Various threats with dire consiguences and "they disclosed that they will demolish your shop House" I tried to resist them and also requested not to do this type of illegal work but instead of they restrained themselves all the accused Person's damage and broken my shop house and they forcibly caught hold of the banch of my hair and fell down on the ground and they were assulting me by lathi and fist and blow. I shouted for help and the accused Persons fled away and when they fled away they had taken my Gas Chula Valved of Rs=5000/- from my shop house.



At that time of departure when I raises hallah the accused Persons threatned me in various way by offensive Language on the point of a sharp cutting weapon on my neck. My son being attracted the hallah came near the spot but as the accused persons armed with deadly weapon he could not do anything.

There after the Matter was brought to the O/C Kotshila Police Station and the Police Officer assured me that appropriate Legal action would be taken against them but unfortunately till to day no action or any specific case has yet been started against the accused Persons and they still threatening me in Various way then on 28-7-2021 the Complainant lodge another Complain to the Superintendent of Police Purulia but the same is fail then the complainant under Compelling Circumstances is filling this Complain before the Ld. Court for appropriate reliefs under the Law.

It is there fore prayed that your honour shall graciously be Pleased to sent the Petition of Complaing to the Officer in-Charge Kotshila PPS, treating the same as FIR under Sestion 156(3) Cr.P.C for investiga-tion.
