Sir,

In producing here with one accused person Hemanta Ruhidas (35) S/o Lt- Ashoke Ruhidas of village Jamgoria, PS Manbazar District Purulia along with following seized articles viz-

- (1) 22 (Twenty Two) Ltrs. ID liquor within a Plastic Jarikane
- (2) 12 pieces plastic glasses
- (3) 375 M.L ID liquor collect from the Jarikane as sample

I S.I. Soumen Kumar Panda of Manbazar PS do here by lodged a complaint against accused namely Hemanta Ruhidas (35) S/o Lt- Ashoke Ruhidas of village Jamgoria, PS Manbazar District Purulia to the effect that today (07.10.2021) at 16:45 hrs. I received a telephonic information from a reliable source that one Hemanta Ruhidas (35) S/o Lt- Ashoke Ruhidas of village Jamgoria, PS Manbazar District Purulia was stocked ID liquor illegally and selling the same to hike price for his personal gain then I noted this information in GD vide Manbazar PS GDE No- 282 Dtd 07.10.2021. I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along with C/638 Lalchand Bag, NVF/537 Asit Kr. Mahato rushed to the spot for raid by Govt. vehicle. At about 19:05 hrs. myself along with force reached at Jamgoria village and held raid in the house of Hemanta Ruhidas and found that said house owner selling ID liquor at his own house and Seeing the police party some persons fled away and said Hemanta Ruhidas tried to concealed himself but we are able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling ID liquor, but he failed to produce any valid license or documents for possessing / selling the same. So I arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after proper seizure list duly signed by accused person and available witnesses.

Hence, I therefore pray that a specific case may kindly be started against arrested accused person Hemanta Ruhidas (35) S/o Lt- Ashoke Ruhidas of village Jamgoria, PS Manbazar District Purulia as per law and arrange for its investigation.
