In producing herewith Eight Tractors fitted with approx. 100 cft each sand loaded Trolley van as per seizure list, having Reg No- 1) WB 55A/9778, 2) WB 55B/2250, 3) WB 55A/3379, 4) WB 55B/1827, 5) WB 55A/0215, 6) WB 55A/6062, 7) Engine No- J68192, ChassisNo-927113192874&8) EngineNo-RMM2EAN0984, ChassisNo-MBAEXKMRM05012. The fact of the case in brief is that on 07.10.2021, I, A.S.I. Anirban Banerjee along with C/336, Kartik Ch Roy, C/1353, Atanu Ganguly . Vide Manbazar P.S C.C No 3963/21 and GDE No- 276 dt- 07/10/2021 were engaged for evening mobile duty. Then at 20.05 hrs received a credible source information that large scale theft of sand is going on from Rangatard mauza at Kumari River bed since morning. I passed information to O.C Manbazar P.S to support extra officer and force for working out the information. Thereafter A.S.I Subhandu Mahato , A.S.I Manik Ch Mahato along with CV boys team joined with us vide GDE No- 290 dt- 07/10/2021 , Being arrived at Rangatard Mauza at Kumari river bed found the above-mentioned Tractor illegally loaded with sand were coming in a row by lifting sand from Rangatard Mauza at Kumari river bed . Being found the police party all the drivers manage to escape from that anticipated place. As such there is every reason to believe that the driver and owner of the above-mentioned Tractors with ill motive are transporting & lifting sand illegally without any valid document in support of carrying / Lifting sand and they habitually deal with the business of stolen sand in a clandestine manners since few days. So, they are liable for offence punishable U/S - 379/411/413/414/120B IPC & 21 (1) (4) Mines and Minerals (R&D) Act. 1957.

Therefore, I pray before you that a case may kindly be started against the driver and owner of the above-mentioned Tractors and oblige.
