

This is to inform that today on 22 OCT 2021 at around 9:00 am, few persons (detail attached) of automobile Hub has assaulted Mr Naimullah Khan (Age-52 yrs) due to which he is severely injured while deployment for daily duties.

Subsequently, these six persons (detail attached as annexure-1) along with 15-20 persons have gathered at main gate of SIPL, and stopped the movement of vehicles from main gate.
