Sohan Rajwar of village- Bhalkhuria, P.O- Dubra, PS- Para, Dist. Purulia has stored huge quantity of ID Liquor for selling. Accordingly I informed it to O/C Para PS and as per his instruction in between 17.05 hrs to 17.30 hrs I held raid in the house of Jimu Rajwar (48yrs) S/o Lt. Sohan Rajwar of village- Bhalkhuria, P.O- Dubra, PS- Para, Dist. Purulia and found that the above noted person was selling country spirit contained in bottles named as "DIL KHUSH". On seeing Police the people who were buying liquor fled away. I asked the above noted person to produce license for selling such liquor, but he did not have any authorization or license in support of said ID Liquor.
