Purulia has stored huge quantity of ID Liquor for selling. Accordingly I informed it to O/C Para PS and as per his instruction in between 16.05 hrs to 16.45 hrs I held raid in the house of Asish Tantubay (47yrs) S/o Harendra Tantubay of Village- Bhagabandh, PS- Para, Dist. Purulia and found that the above noted person was selling country spirit contained in bottles named as "DIL KHUSH". On seeing Police the people who were buying liquor fled away. I asked the above noted person to produce license for selling such liquor, but he did not have any authorization or license in support of said ID Liquor. So I seized 18 (Eighteen) bottles of 'DIL KHUSH' country spirit containing 600 ml each which were kept in there under proper seizure list in presence of witnesses duly signed by them. I also arrested the above noted person maintaining all rules and guidelines provided by NHRC/WBHRC and informed his family members.
