In producing herewith one arrested accd. person namely Kailash Singh (32yrs) S/o Lt- Sankar Singh permanent address Village- Shyampur, PS- Purulia (M), Dist- Purulia A/P, C/o Lt- Sunil Roy of Village- Patharkuchi, PS- Para, Dist. Purulia with seized article i.e 18 (Eighteen) Pcs sealed bottles of Country Spirit styled as "DIL KHUSH" each Bottle contains 600 ml in which 01 (one) bottle as sample which were seized under proper seizure list, I beg to submit that today (07.10.2021) during my Evening mobile duty I received credible source information that one Kailash Singh (32yrs) S/o Lt- Sankar Singh permanent address Village- Shyampur, PS- Purulia (M), Dist- Purulia A/P, residing at his in-laws house of Village- Patharkuchi, PS- Para, Dist. Purulia has stored huge quantity of ID Liquor for selling. Accordingly I informed it to O/C Para PS and as per his instruction in between 19.15 hrs to 19.30 hrs I held raid in laws the house of accused Kailash Singh of village- Patharkuchi, PS- Para, Dist. Purulia and found that the above noted person was selling country spirit contained in bottles named as "DIL KHUSH". On seeing Police the people who were buying liquor fled away. I asked the above noted person to produce license for selling such liquor, but he did not have any authorization or license in support of said ID Liquor. So I seized 18 (Eighteen) bottles of 'DIL KHUSH' country spirit containing 600 ml each which were kept in there under proper seizure list in presence of witnesses duly signed by them. I also arrested the above noted person maintaining all rules and guidelines provided by NHRC/WBHC and informed his family members.

The above noted arrested accd. namely Kailash Singh (32yrs) S/o Lt- Sankar Singh permanent address Village- Shyampur, PS- Purulia (M), Dist- Purulia A/P, C/o Lt- Sunil Roy of Village- Patharkuchi, PS- Para, Dist. Purulia committed offence u/s 46 A(c) B.E. Act. 1909 for unauthorized possession and sale of said liquors.

Under the above fact and circumstance I therefore pray that a case u/s 46 A (c) B.E. Act'1909 may kindly be started against Kailash Singh (32yrs) S/o Lt- Sankar Singh permanent address Village- Shyampur, PS- Purulia (M), Dist- Purulia A/P, C/o Lt- Sunil Roy of Village- Patharkuchi, PS- Para, Dist. Purulia and arrange for its investigation.
